 - Dr. Fagan presented Campbell his award and recognized his heroism during a very serious crisis during a hiking trip with his dad. His quick thinking and calmness saved his dad's life.

 - Mrs. Lillie presented award to Cassy for coordinating the program, which helped over 80 families in our district. Her hard work and dedication are invaluable to this program.

 - Mr. Mazzi presented awards to the board and thanked them for their hard work. All the meetings they attend and volunteering their time to study between meetings. He commended them that they stay abreast of situations, numerous phone calls and committee work. Each member received a certificate of appreciation.

6. Treasurer's Items

- A. Monthly Report
 - Monthly Activity In December we completed the compilation of our "Comprehensive Annual Financial Report" (CAFR) and Audit for Fiscal 2012. You'll be pleased to know we once again received "unqualified" or "clean" audit option, which is the highest and best opinion for financial reporting.
 - Revenue The other budget variance you may notice is the fluctuation with Other Local Sources in the amount of \$152,887. The fluctuation reflects the timing difference of the receipt of our Build America Bond interest. We received Build America Bonds (BAB's) interest rebate of \$110,884 in November. Future BAB reimbursements may be reduced by up to 7.6% (or \$16,854 annually) due to the implications from the "Fiscal Cliff", which results in reductions of subsidies paid by the federal government.
 - Expenditures Actual monthly expenditures of \$2,344,634 are \$117,828 less than projected for the month of December, primarily as a result of the capital outlay category. The next major fluctuation has occurred in benefits revealing a decrease of \$50,954. This decrease in benefit costs is the direct result of labor contract negotiations that led the district to change group medical insurance carriers as of January 1st from Medical Mutual to United Health Care. In conclusion, the outcome of the last six months of operations reveal that revenue is 1% over projections and expenses are 1% under projections leaving us with an overall 3% increase in year-to-date cash balances including transfer and advances.

7. Superintendent's Items

- A. Middle School Math Grading Presentation
 - Penny Sturtevant indicated the math department is working to reflect on how the department is grading and where they need to be in the future.
- B. Security Update
 - Mr. Barber indicated the district is being hyper vigilant in the safety and security of the buildings. The district has spent countless hours reviewing and revising safety plans and procedures, completing safety audits, reviewing recommendations, completing drills, listening to full staff presentations from national safety experts, completing table top simulations, and making changes to how visitors and students enter our building after the start of our school day. We will be adding another proactive strategy starting Wednesday, January 23rd, with the implementation of The Safe School Hotline. This vehicle will give students, staff, parents and community members the opportunity to anonymously report anything that may put our students, staff or schools in danger. This would include reporting a crime, harassment, drug or alcohol abuse, reckless driving or any other illegal activity that could affect our district. A caller may make a report 24/7 and the schools will be notified. Licensed counselors will be on the phone and they will relay the information to designated district personnel. The Safe School Hotline utilizes a unique, automated telephone service which allows callers to report

an allegation or concern confidentially and anonymously. AiPhones installed at BWE, SOU and BWIS; not foolproof provides control and awareness of who is entering the building.

 - Dr. Fagan informed everyone she attending the New Board President training. She thanked the admin team for the safety work that was done over break. She stated that Vinmar Village is going through zoning for 87 single family homes. Phase 1 will be 30 lots starting fall of 2013 with occupancy in 2014. This will be valuable in the planning of facilities and staffing.
