# Treasurer's Items

#### A. Monthly Report

- Monthly Financial Activity: During the month of October, revenue of \$2,486,286 exceeded expenditures of \$2,125,470 by \$360,816 that was primarily due to the receipt of income tax collections of \$83,381.
- Revenue: Monthly revenue of \$2,486,286 was less than projected due to the timing of the anticipated receipt of the interest rebate of \$110,882 and the tangible personal property (i.e. TPP) subsidy of \$132,133. The TPP amount is ½ of the H.B. 66 Direct Subsidy Payment of \$264,268 for fiscal 2012. The balance of the TPP subsidy is to be received in May 2012. Please note that last years' district subsidy payment from the state was \$735,496 for TPP. This reduced collection of TPP reflects Governor Kaisck biennial budget that accelerated the phase out of TPP.
- Expenditures: Monthly expenditures of \$2,125,470 are less than projected by \$101,478, primarily in the purchase services category. The variance in expenditures reflects the delayed payment to the Educational Service Center of Central Ohio (ESC) for payment of contracted special educational staff that is likely to be offset with pending credits.

#### Superintendent's Items

- A. Race to the Top Updates
  - Waiver Day
    - Mrs. Pollock explained Waiver Day is the Monday after Thanksgiving and the staff will be working with staff members in other districts. There will be a national speaker on trends in education.
  - New Standards in Technology
    - > Mrs. Pollock stated Ohio is likely to adopt new standards in science and technology; standards are embedded into language arts.
    - ➤ Mr. Mazzi shared that by 2014 all students will be taking test on-line.

- ▶ Board members asked questions concerning the availability and budget for computers for this purpose.
- ➤ Mrs. Pollock indicated I Pad will probably be the best option to support these needs.
- > Dr. Fagan asked about curriculum for the arts.
- Mrs. Pollock answered that it is in the development stage.
- OTES Pilot
  - ➤ Mrs. Pollock said Big Walnut is participating in developing teacher evaluations that show student growth teachers from HS and SOU are participating.

# B. Facility Update

- In Mazzi stated the new buildings are at or near capacity. The Development Committee is examining how to deal with student growth and what to do with HSE, Intermediate and Galena building. The committee will explore how the facilities should function and how much money should be invested in upkeep of the older buildings. The buildings that were built in the late 1800's are really starting to deteriate; the committee will help to evaluate the buildings and their needs.
- Mrs. Lillie inquired about the mold problem at the HS and the Galena building.
- Mr. Mazzi stated that the mold recommendations at the HS have been completed along with trying to solve the gutter issue.

- > Dr. Fagan congratulated band and the new board member elects. She thanked Ms. Hernandez and Ms. Justice for caring enough for the community to run. December 5 and 12 are the middle school band and choir concerts at the high school. Jazz night at SUMC was standing room only and rocked the house.
