WHO CAN EAT AT THE KIDS LUNCH CLUB?

- Students enrolled in school with an IEP up to age 21.

HOW CAN I GET INVOLVED AND VOLUNTEER?

CAN I BRING MY CHILD/CHILDREN?

Children must be 14 to volunteer in food tents but yes you can bring your children. In fact, we encourage it!

Bringing kids to a program like this can often be very eye-opening and educational.

CAN MY CHILDREN EAT?

Absolutely! Your kids eating with our kids is a strong relationship building activity. We adjust the number of meals we order each day and are reimbursed for the meals we serve by the USDA.

WHAT ARE THE AGE REQUIREMENTS FOR VOLUNTEERING?

Children must be 14 to volunteer if unaccompanied by an adult. However, you may bring children younger than that to come and participate as an educational experience.
