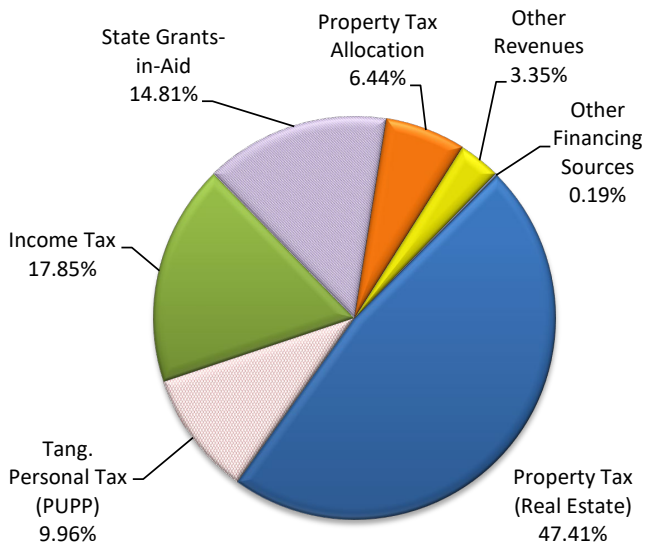

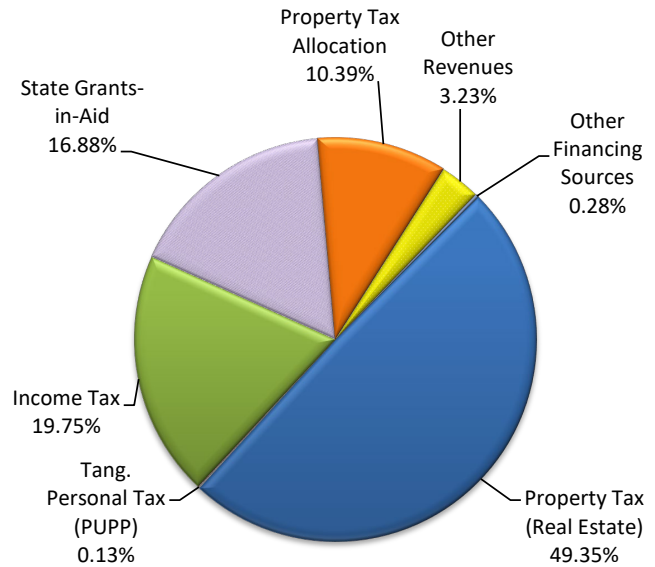

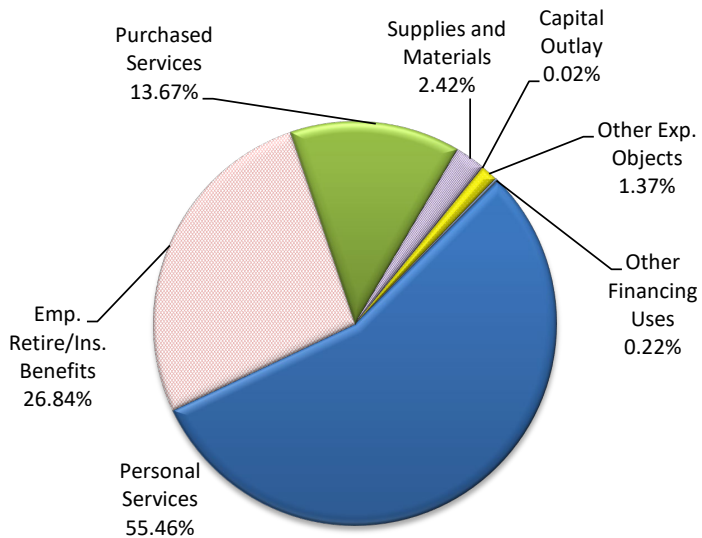
EST. GENERAL FUND REVENUE FY21

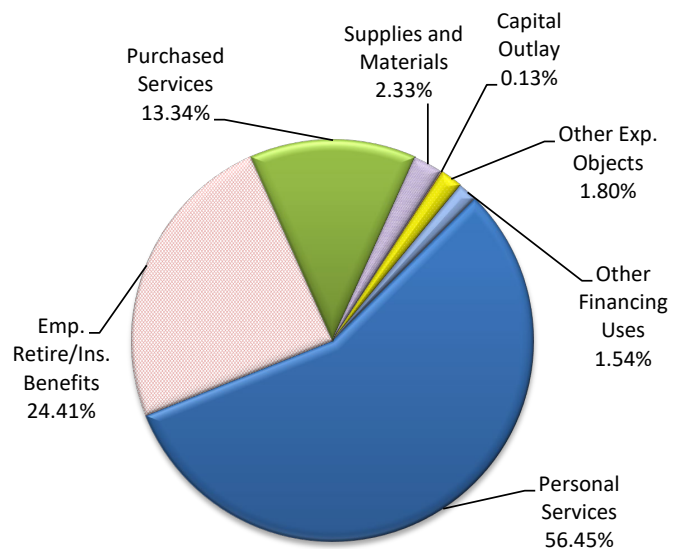
EST. GENERAL FUND REVENUE FY11

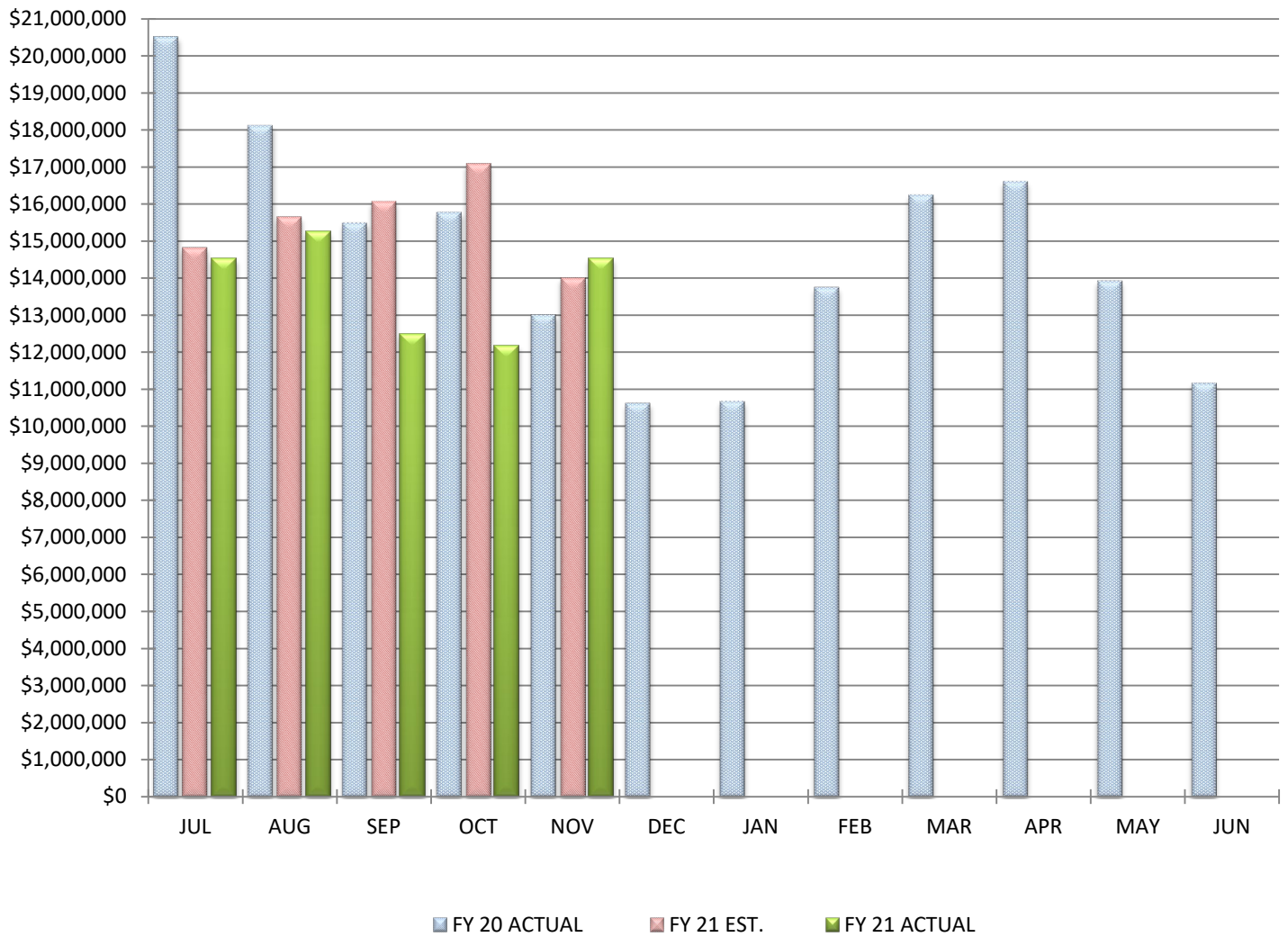

COMPARISON OF MONTHLY ENDING CASH BALANCES



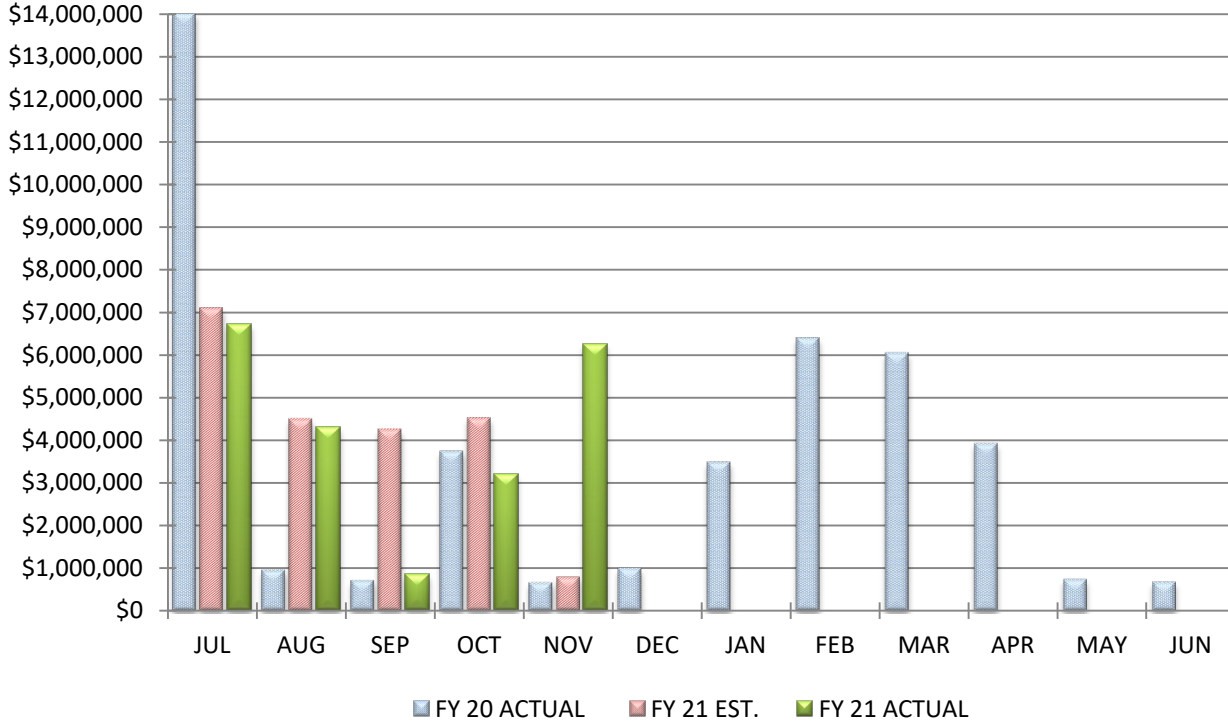

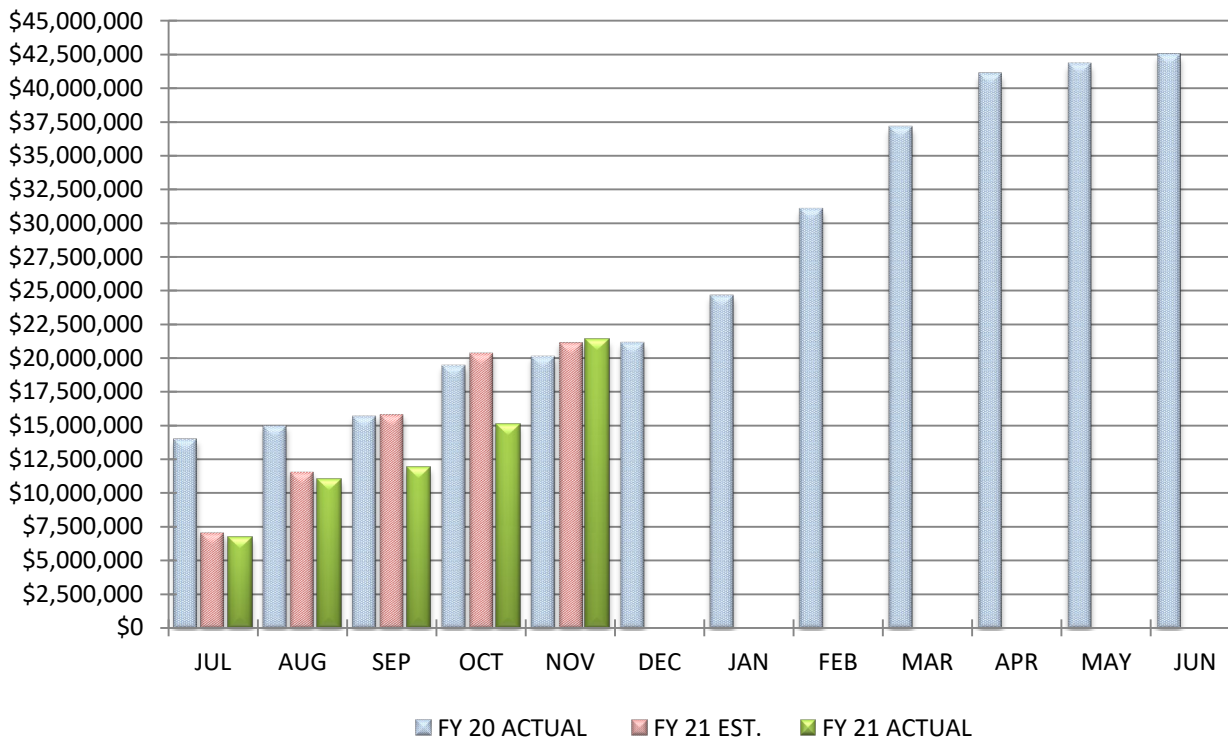

COMMENTS: Our cash balances is slightly above what we would have anticipated for the month of November. We did receive our final tax settlement at the beginning of November and fortunately received our state property tax allocations at the end of November, which was earlier than expected when considering the late receipt of our property taxes. In addition, expenditures have continued to trend slightly under estimated amounts. We are hopeful that we will continue to stay on track with both revenues and expenditures, but we know we will need to continue closely monitor the state and local data regarding recovery and fluctuations from COVID-19. Further detail will be provided in the proceeding pages.

COMPARISON OF TOTAL YEAR-TO-DATE REVENUES & OTHER FINANCING SOURCES

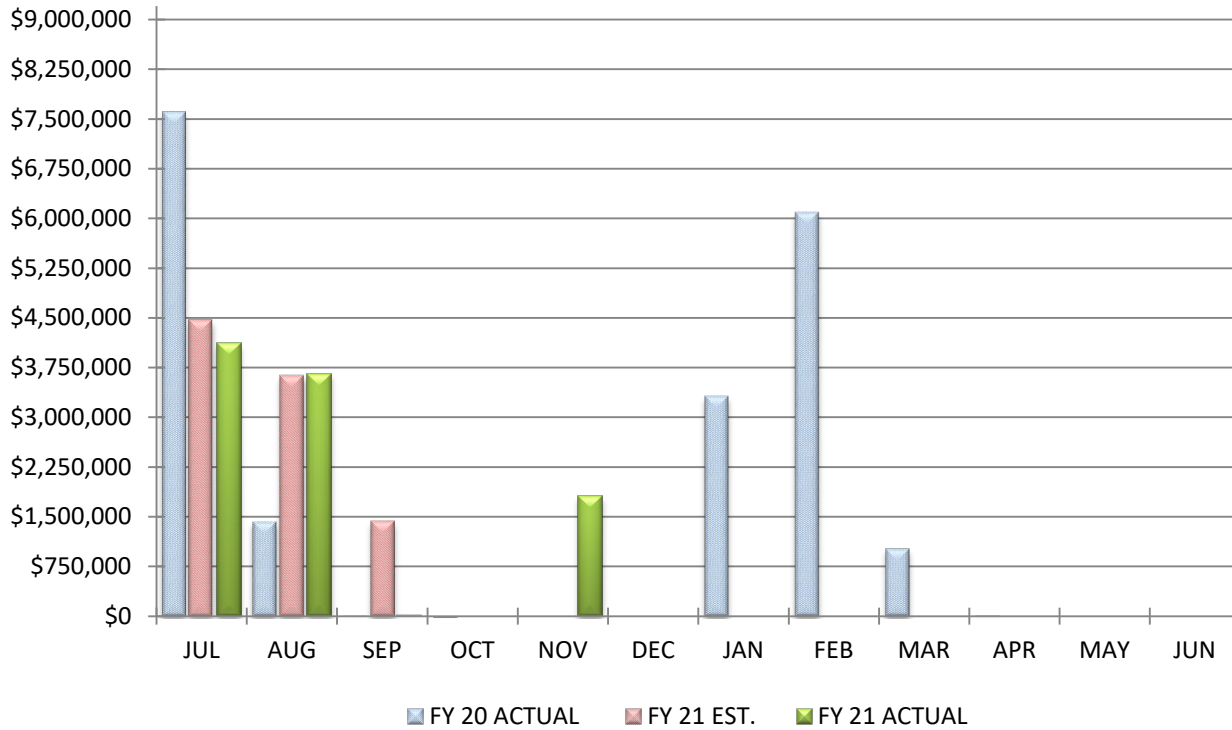

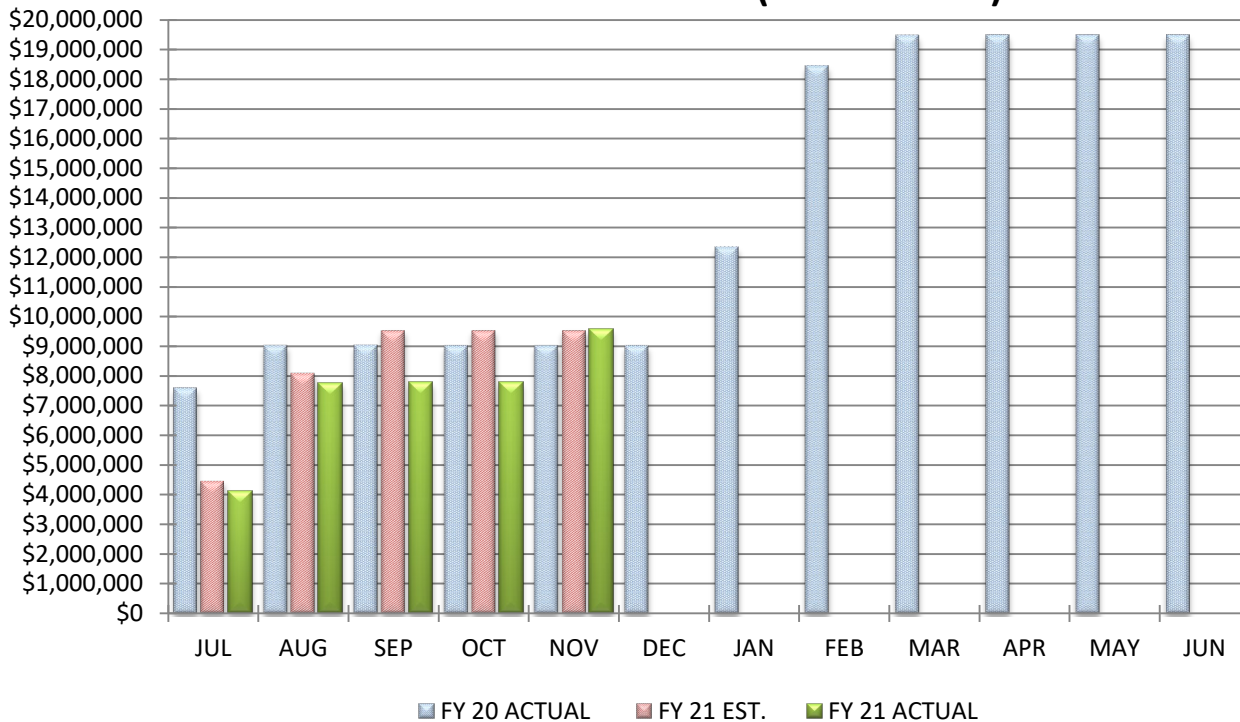

COMMENTS: We experienced a large variance in our monthly actual and estimated revenues due to our final property tax settlement receipts. We did finally receive our final tax settlement at the beginning of November and fortunately received our state property tax allocations at the end of November, which was earlier than expected when considering the late receipt of our property taxes. As noted above, the receipt of these funds has put our actual annual revenues in line with our estimates. With the information we have available at this time, we believe that our estimates are reasonable but will continue to monitor all areas as new local, state, and national economic data becomes available.

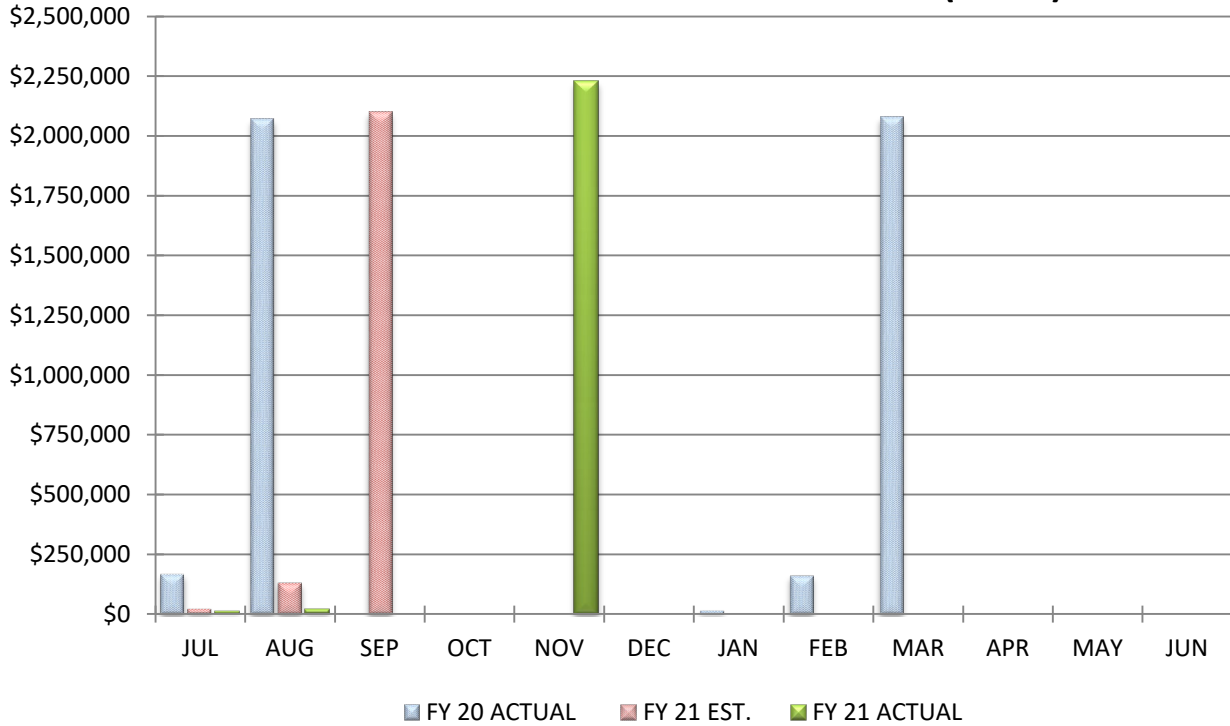

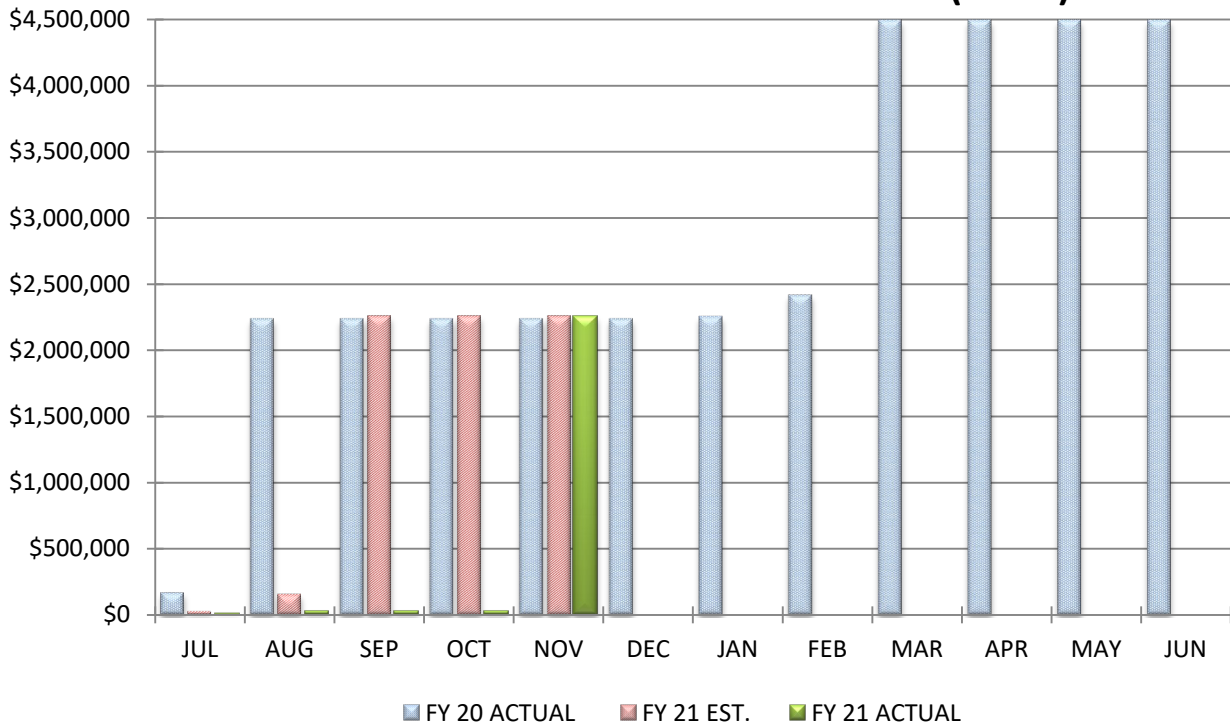

COMMENTS: We are over monthly estimates for property taxes in November but have come in line with year-to-date estimates. We did finally receive our final tax settlement at the beginning of November and are pleased to see that we are in line with our anticipated revenues. We are expecting an increase for the second half of the fiscal year due to triennial update and new construction valuation increases. With the information available at this time, we believe estimated revenues for the year are reasonable and should continue to be in line with projections as the year continues.

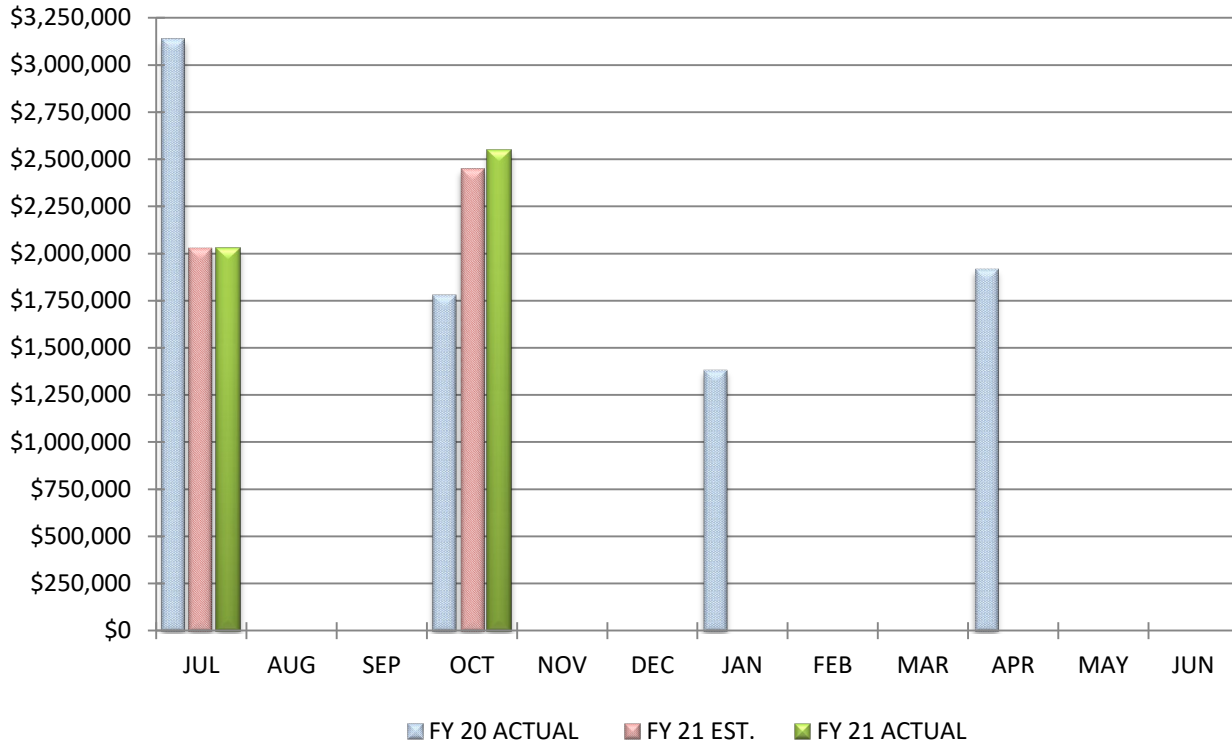

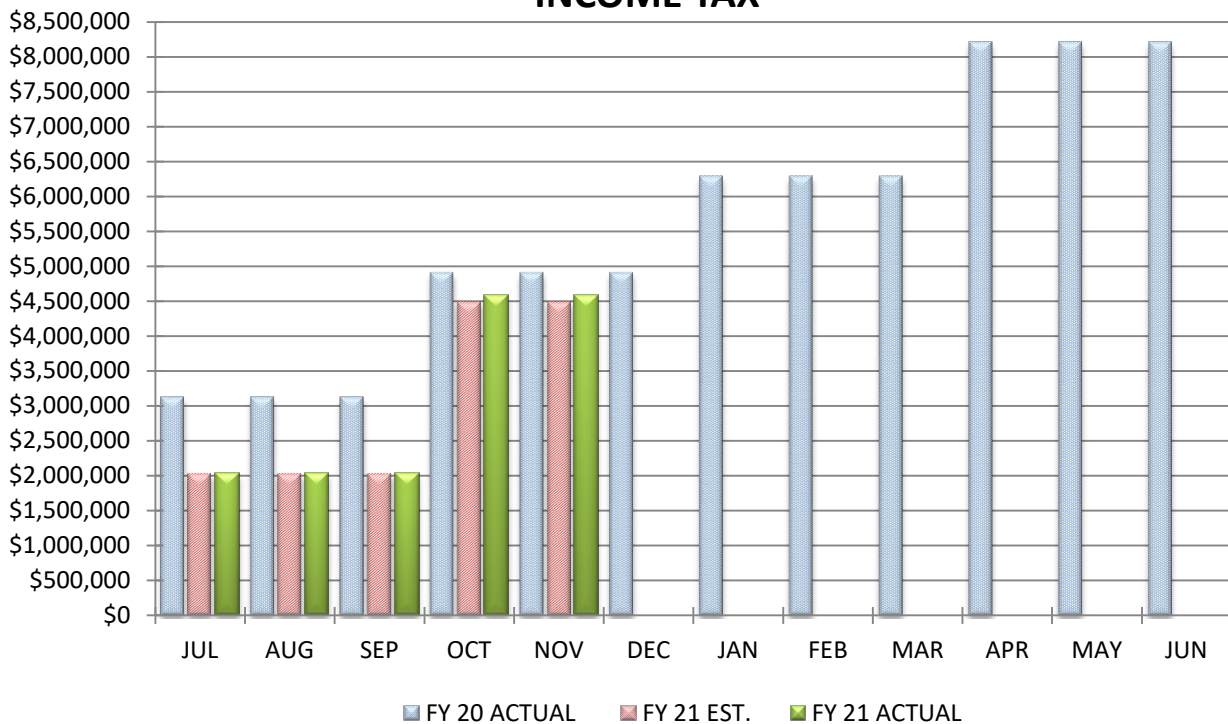

COMPARISON OF TOTAL YEAR-TO-DATE INCOME TAX



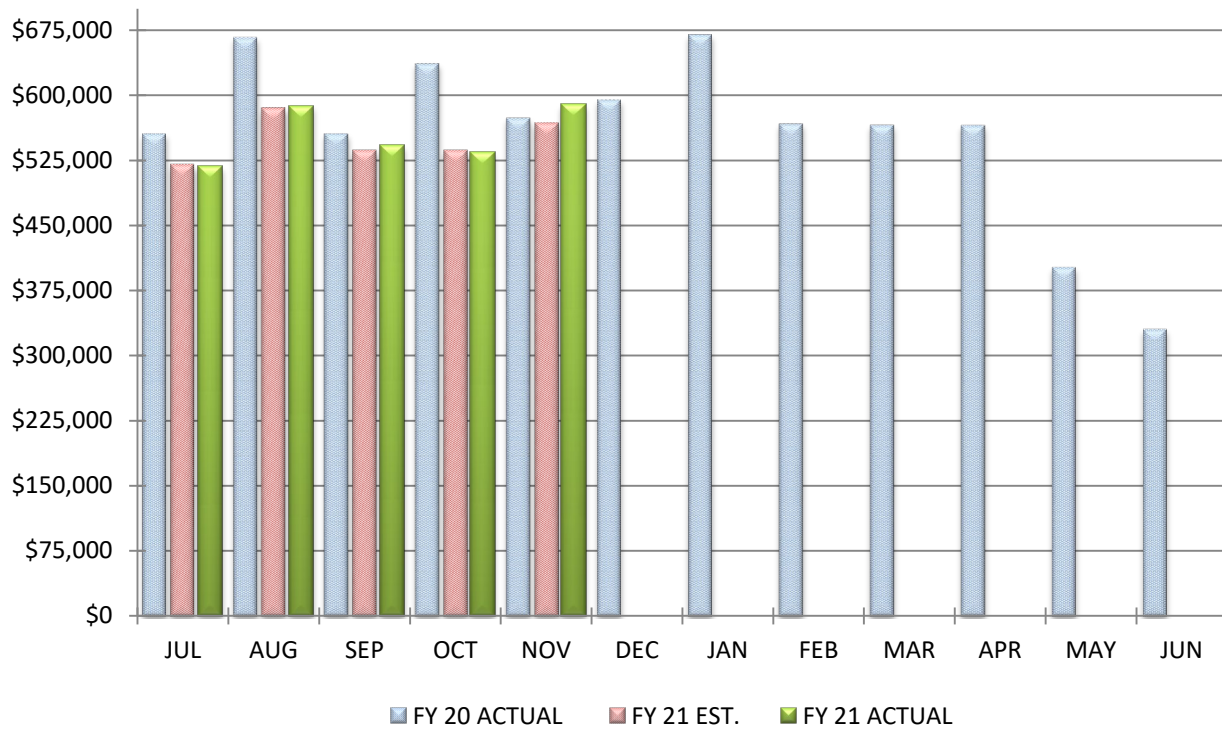

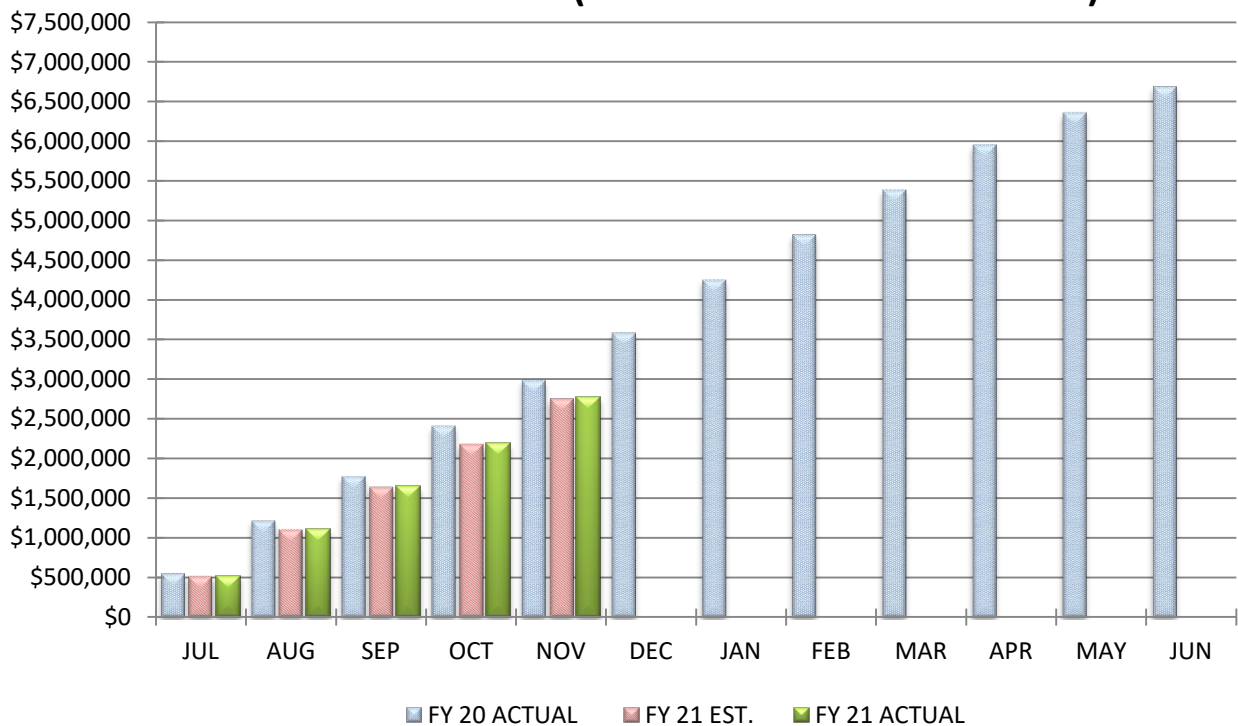

COMMENTS: The impact of the income tax payment and filing deadline being pushed back to July 15th can be noted in the large fluctuation compared to prior years. Our October payment did come in significantly over the amount collected in October of 2019 as expected, but our total collections at this point in the year are lower than a year ago. Due to an uncertain economic climate, we have anticipate a reduction in overall income tax receipts for the fiscal year. We are on target with annual estimates and believe that our anticipated amount for the fiscal year is reasonable.

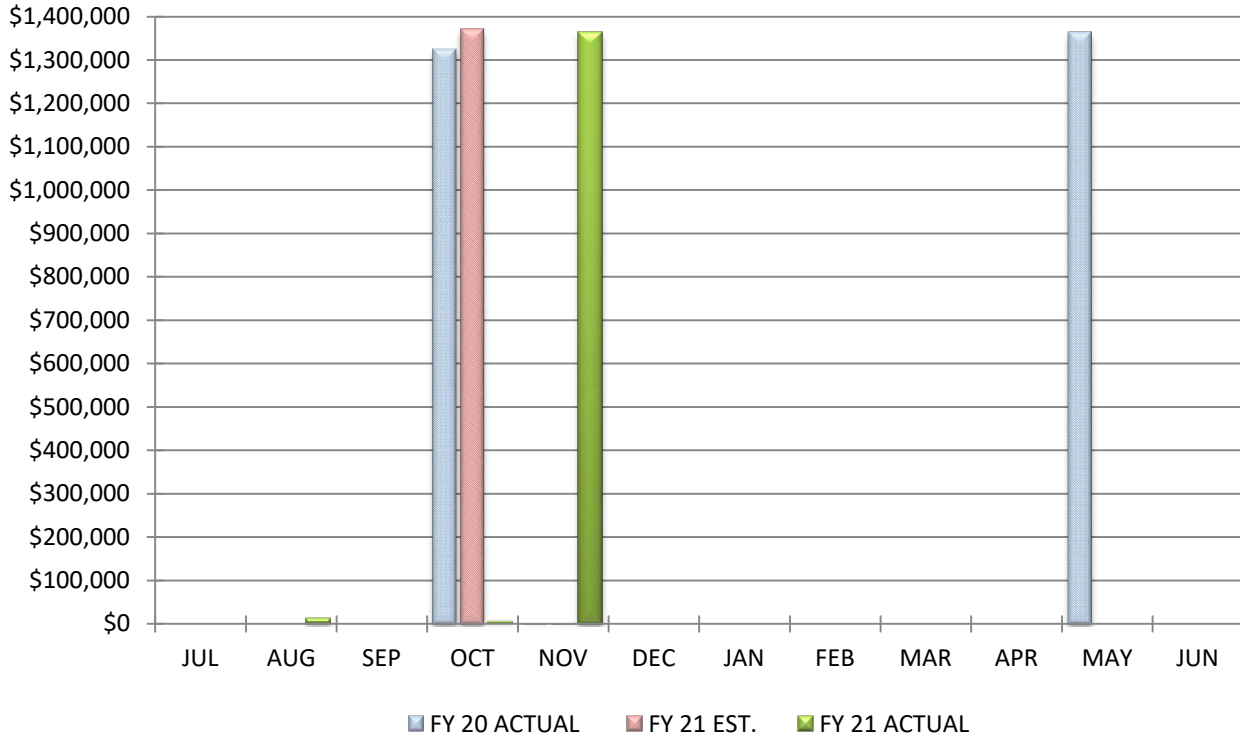

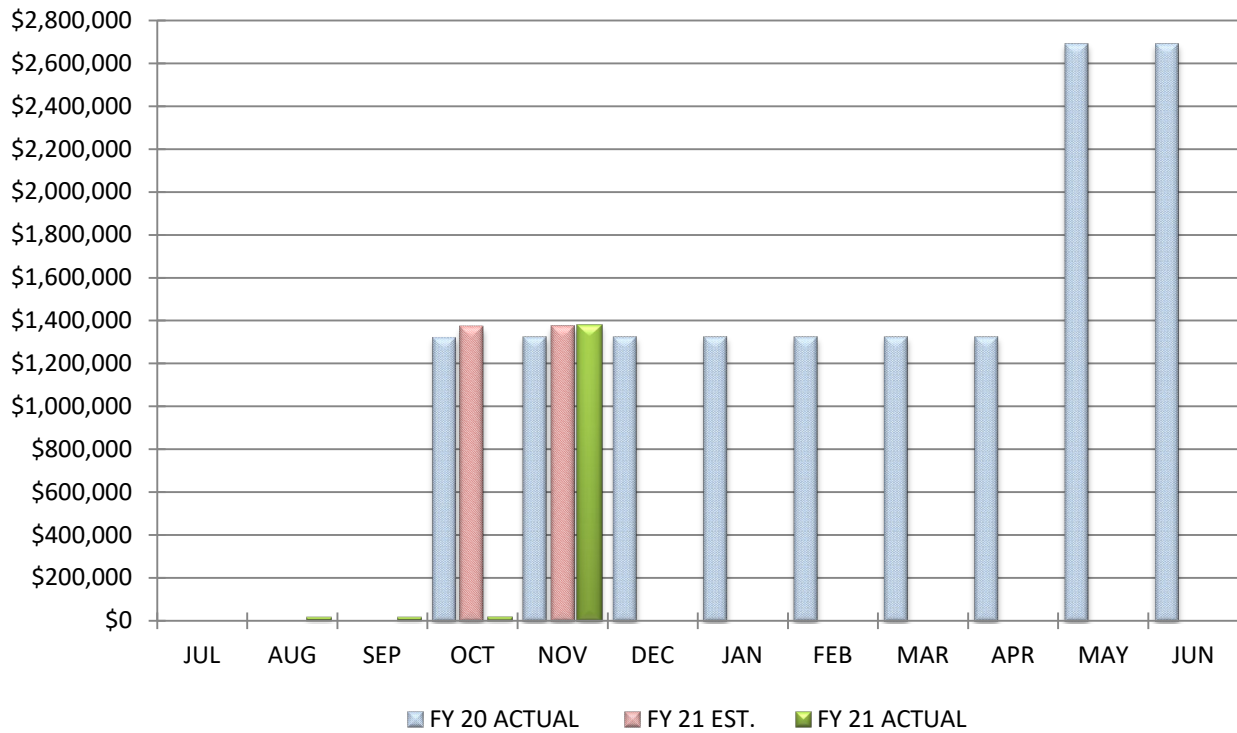

COMMENTS: We are on target with annual estimates, but the impact of the state cuts received in May 2020 can be seen in the differences noted between current year receipts and prior year receipts for the same time period. We did receive and adjustment due to a reconciliation at the state level for enrollment, scholarship deductions, and community school deductions, which provided and increase this month and for the year. We are, however, on track with our annual estimates.

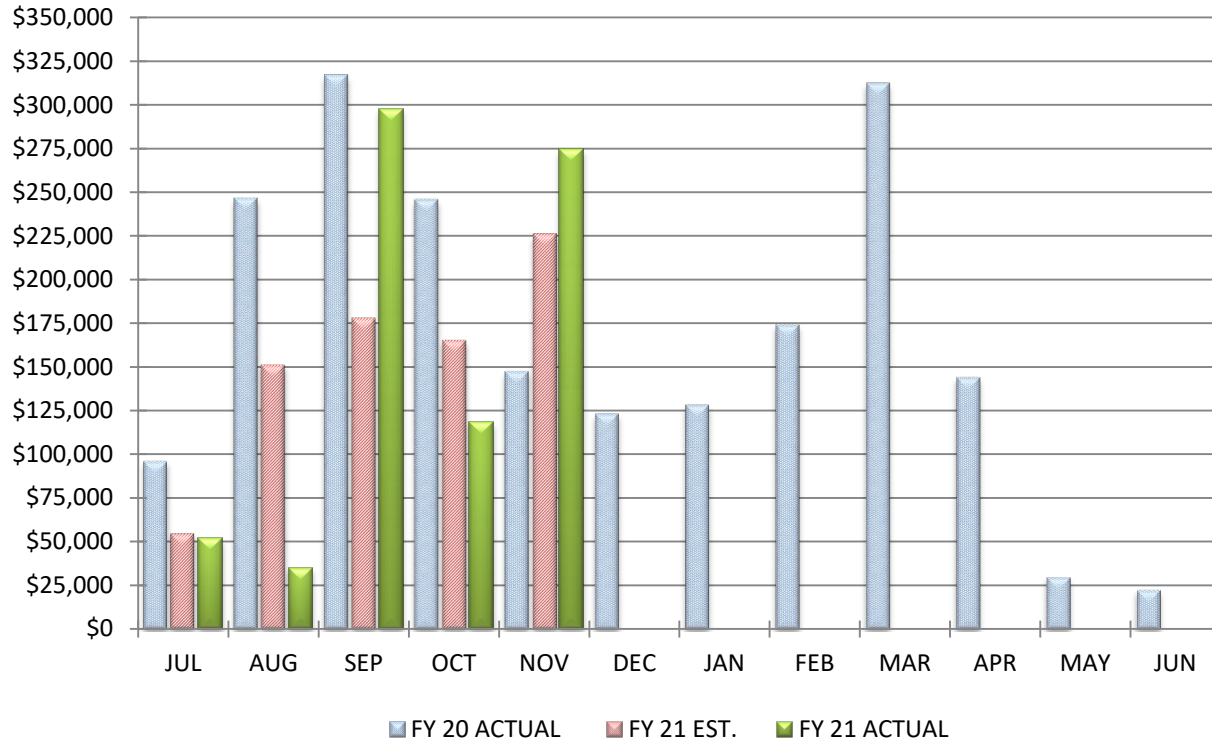

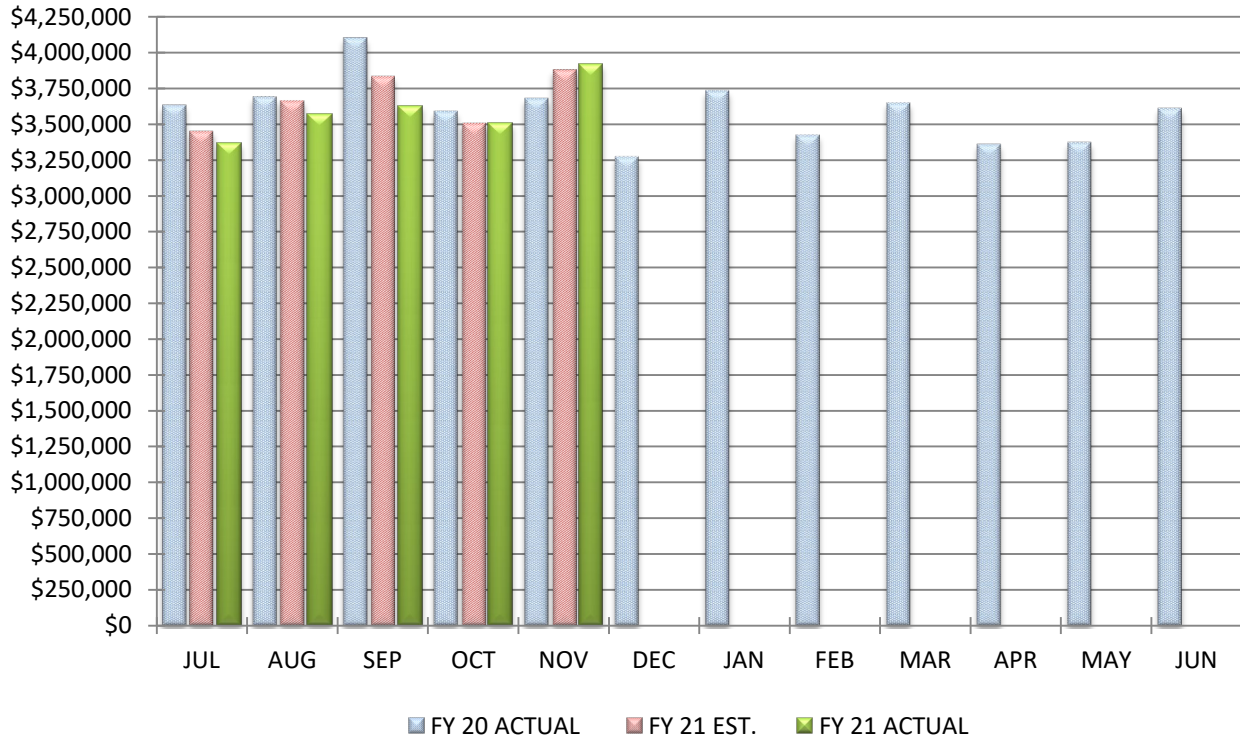

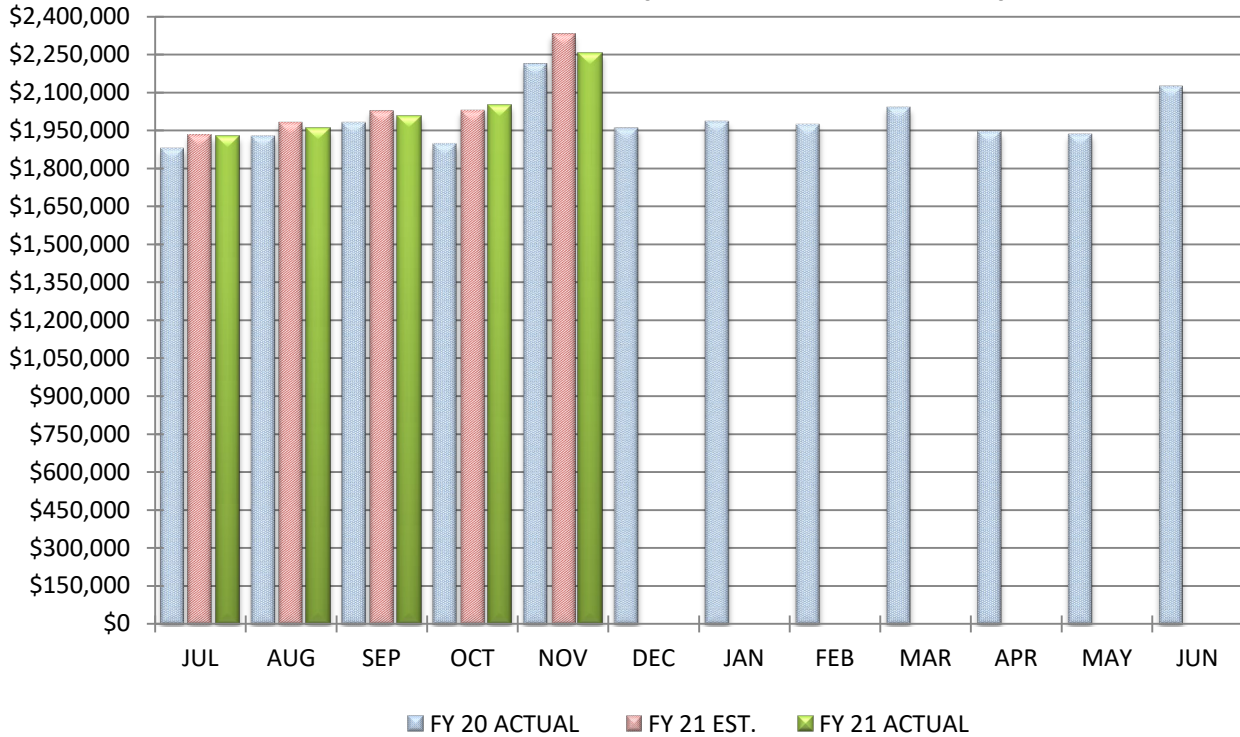

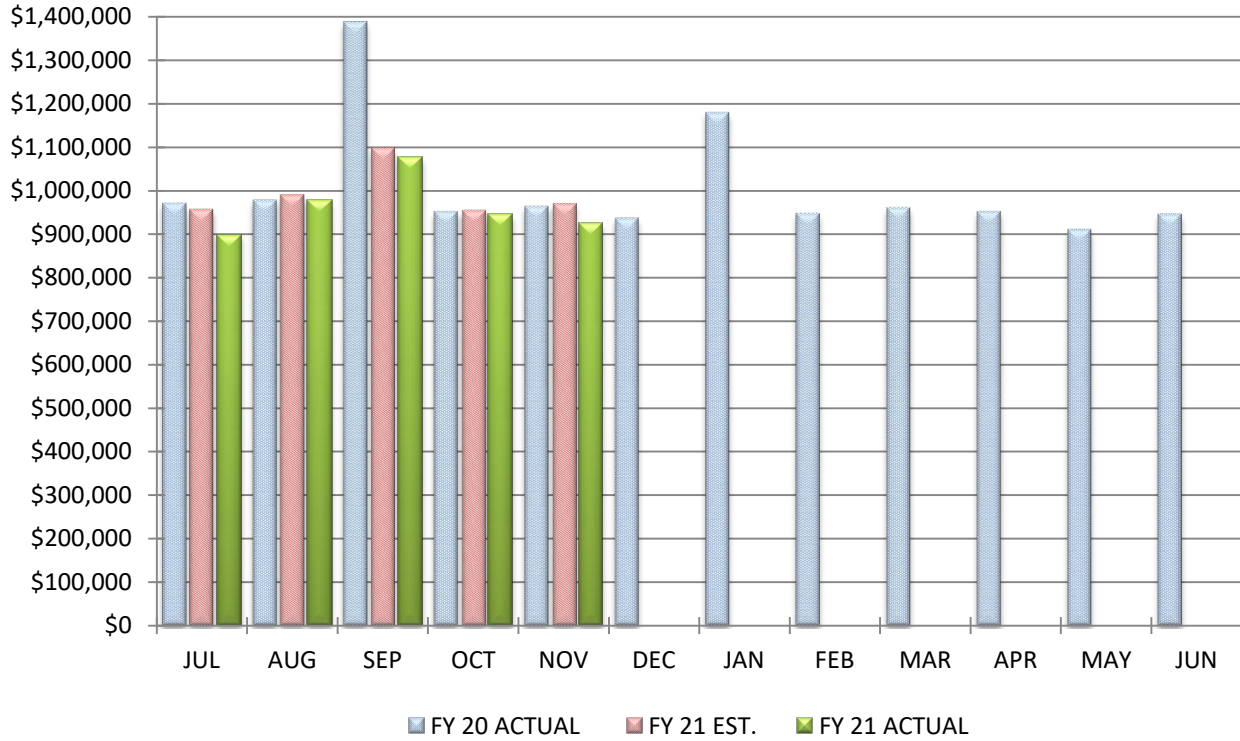

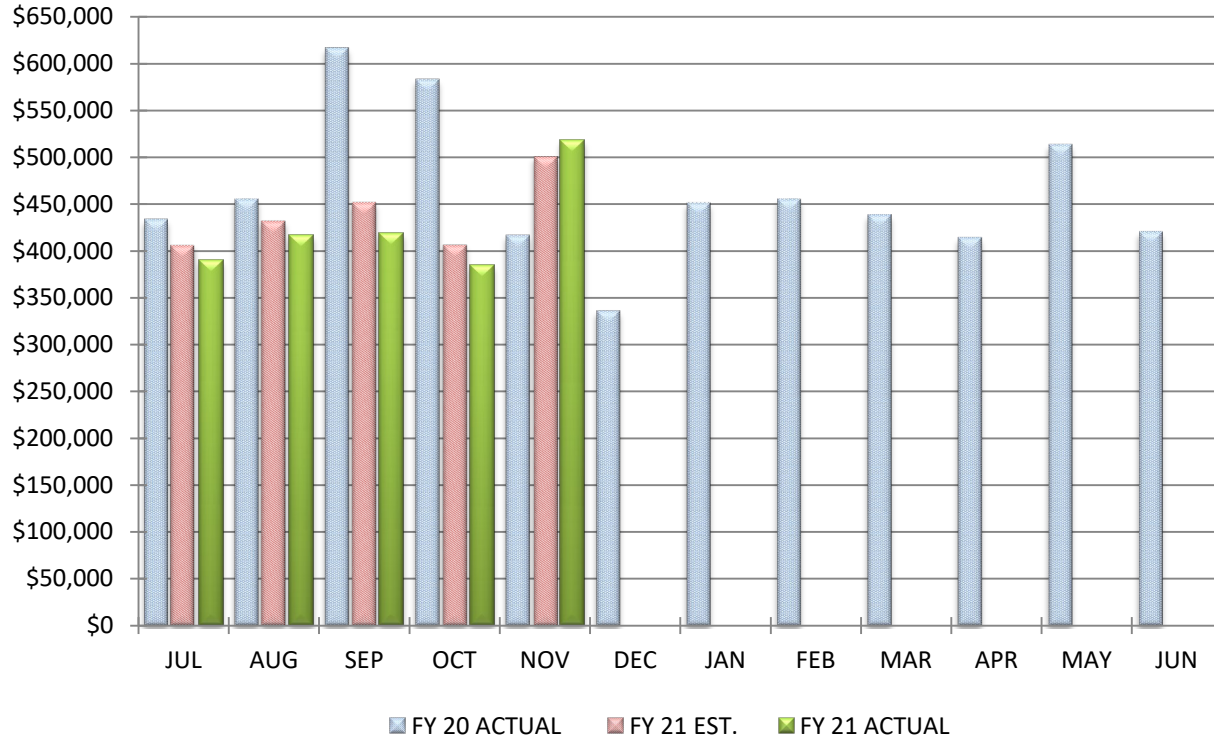

COMMENTS: We are under estimates as of the end of November and for the year. While we are currently seeing a trending slightly under estimates, a big reason for our favorable variance is a \$60,674 COVID-19 credit, which was the portion of the total credit applied to offset United Healthcare July employer medical insurance premiums. With a favorable variance in our Personal Services line our wage-related benefit costs are under lending to the overall favorable variance. We believe that as the year continues we should continue to stay on track in this expenditure area.

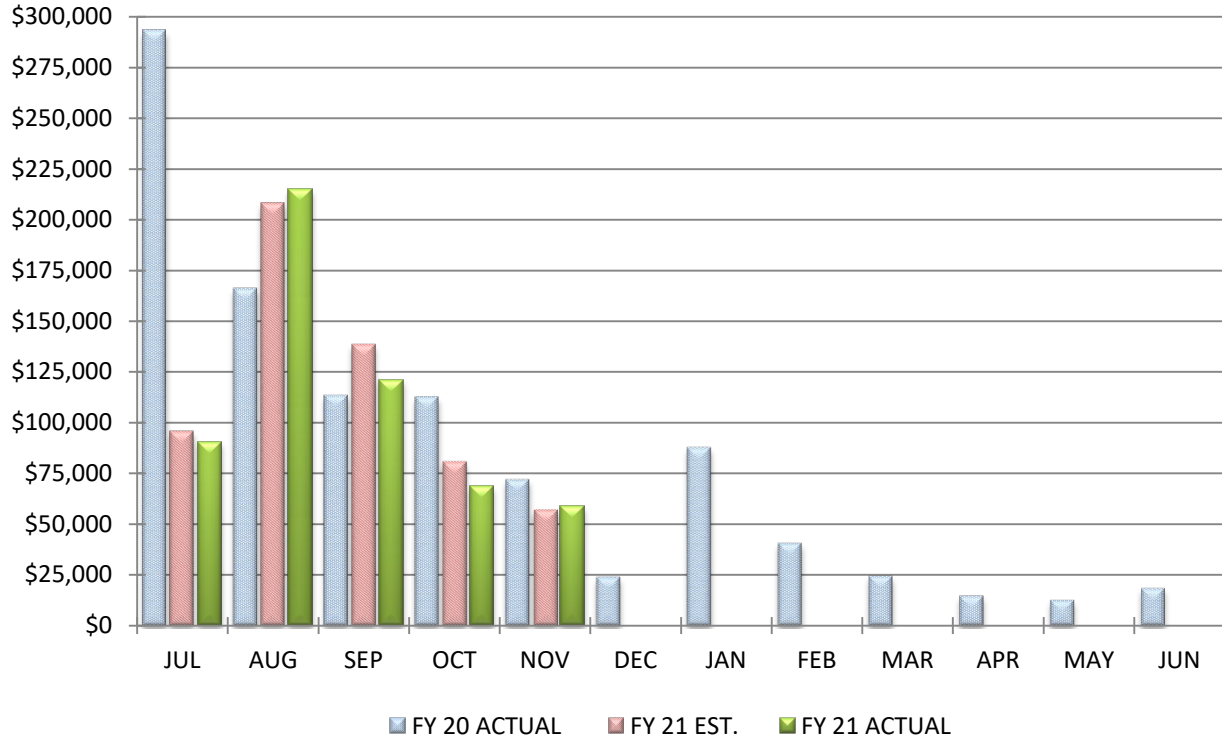

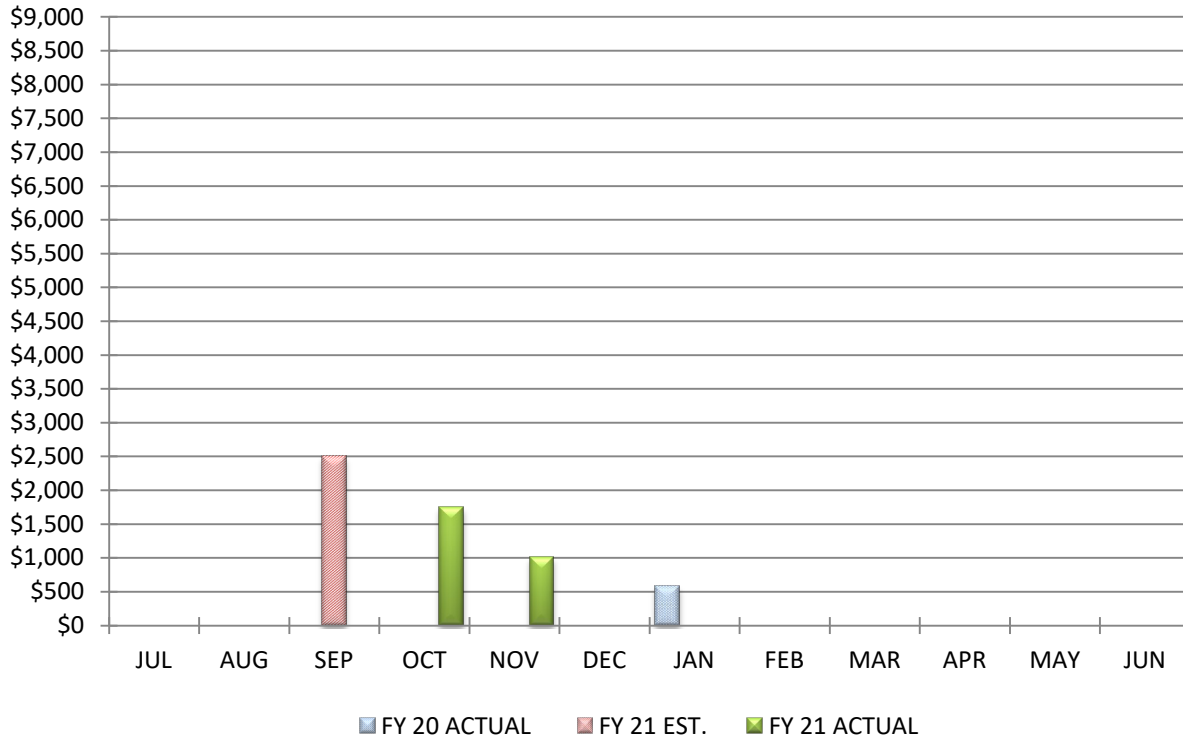

COMPARISON OF TOTAL YEAR-TO-DATE CAPITAL OUTLAY



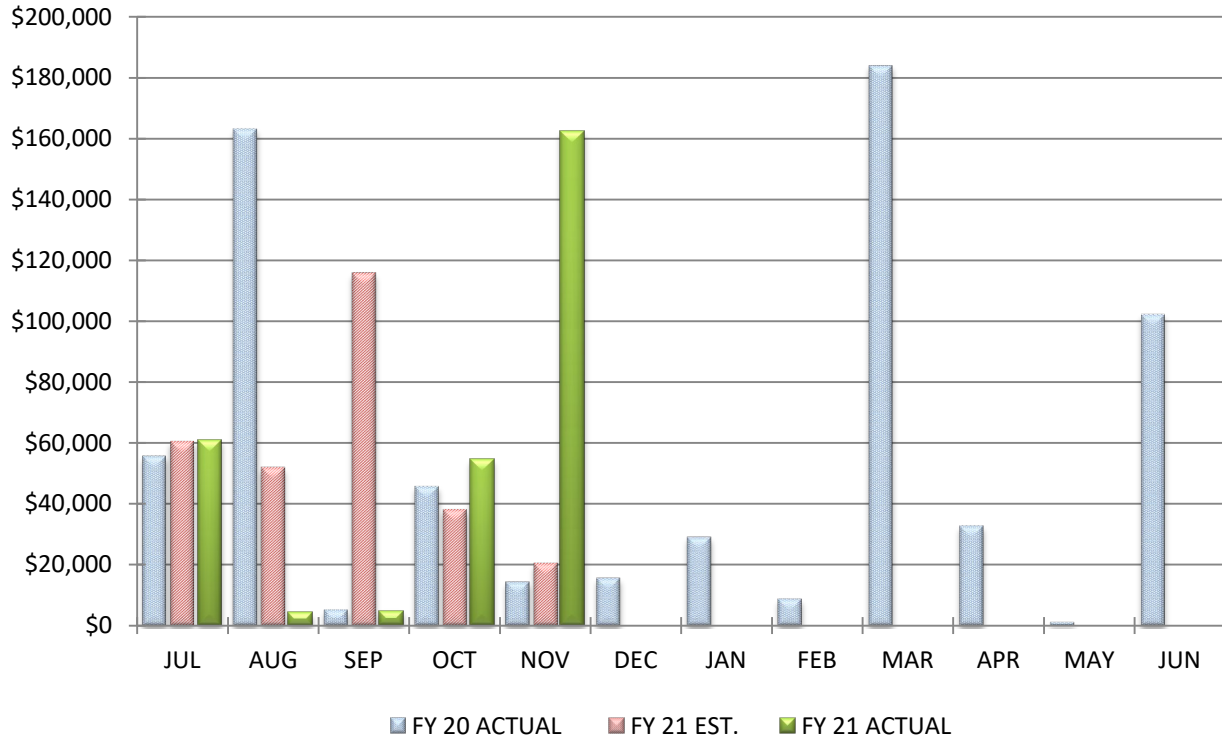

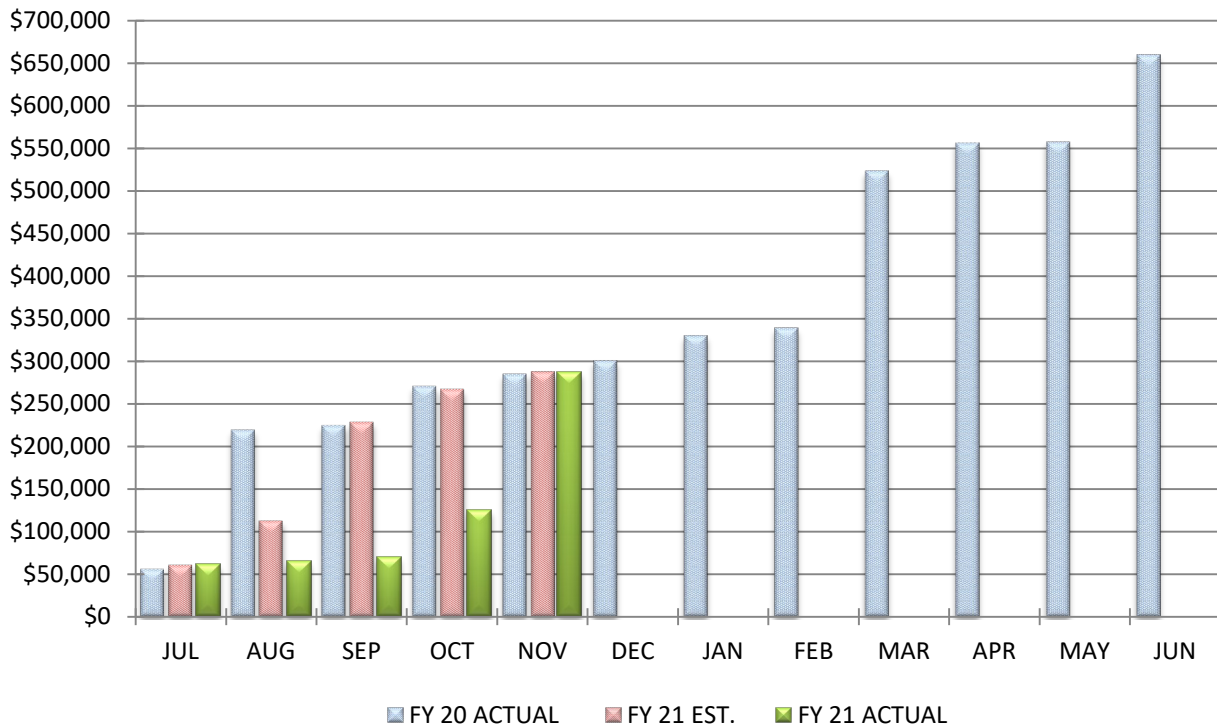
