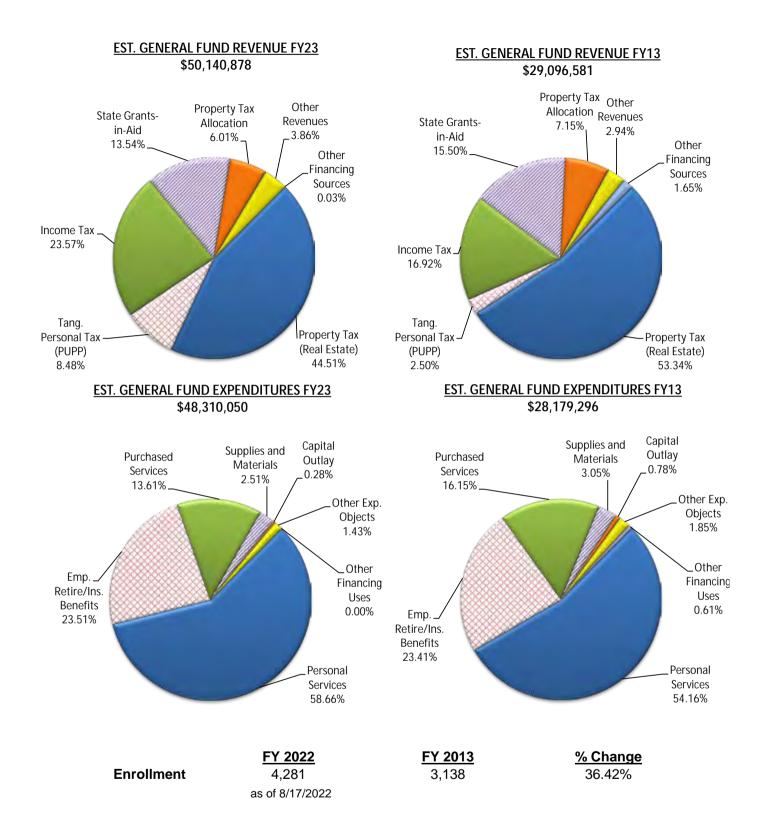

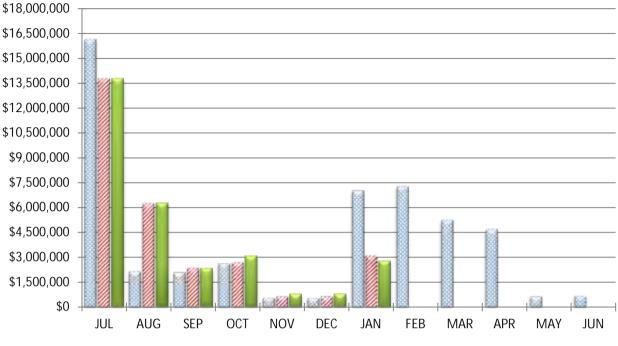

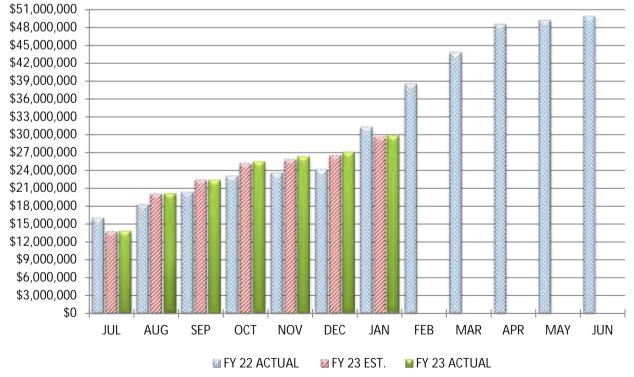

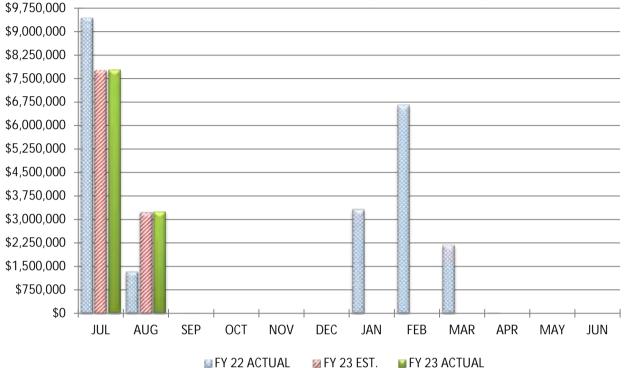

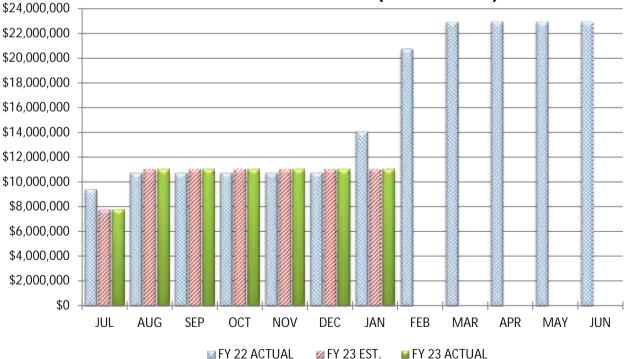

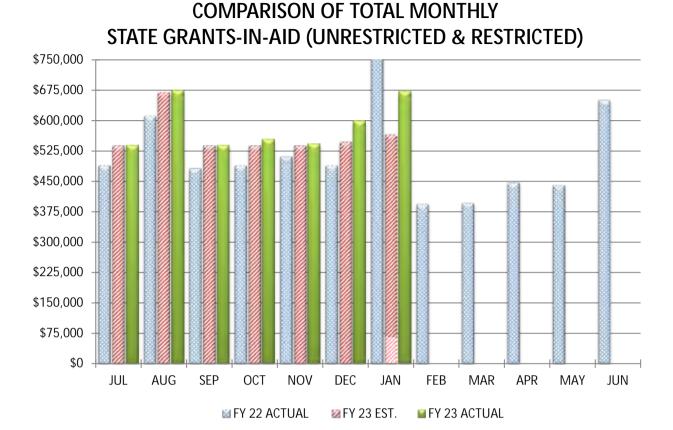
COMPARISON OF TOTAL MONTHLY INCOME TAX



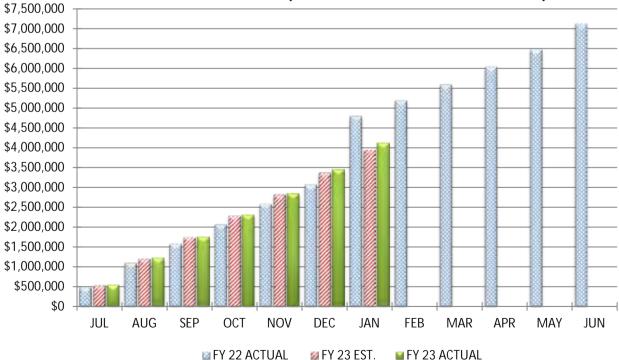

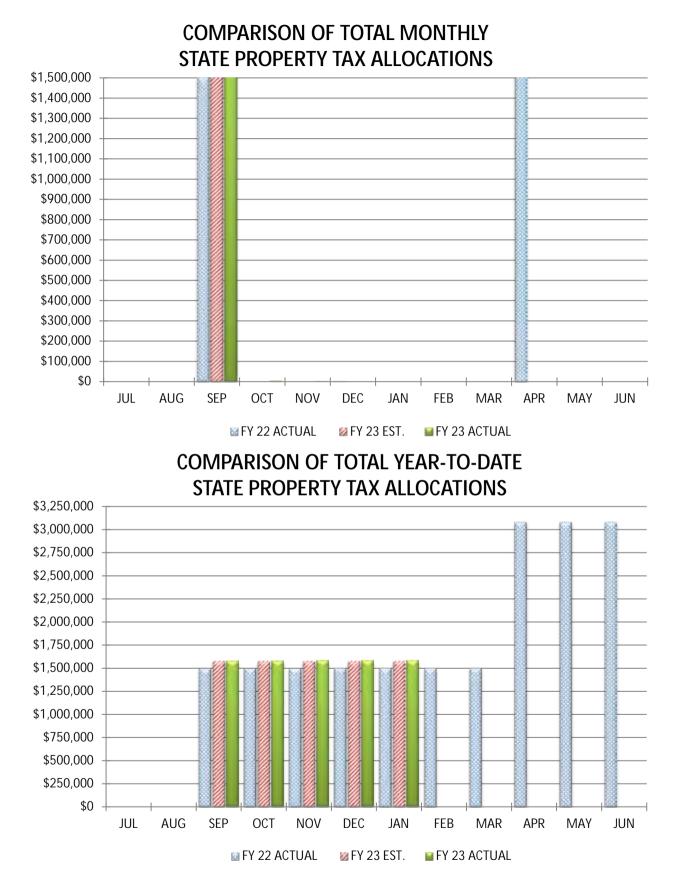

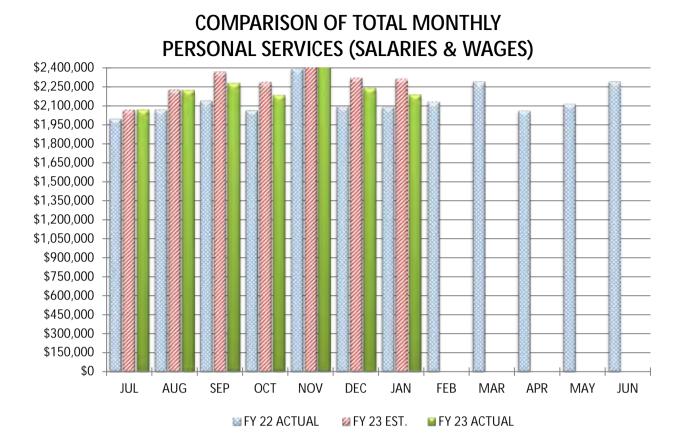

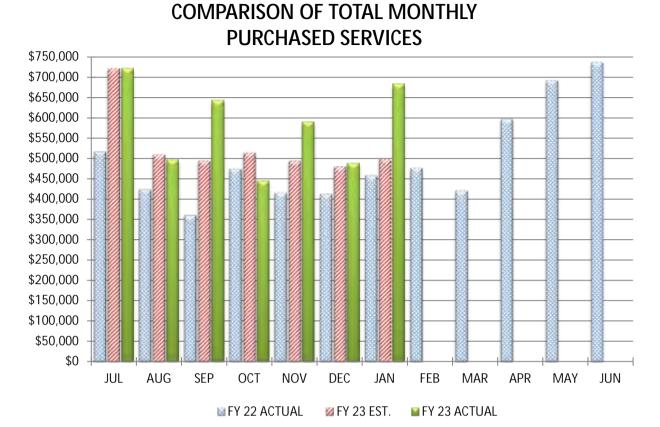

COMPARISON OF TOTAL YEAR-TO-DATE PURCHASED SERVICES



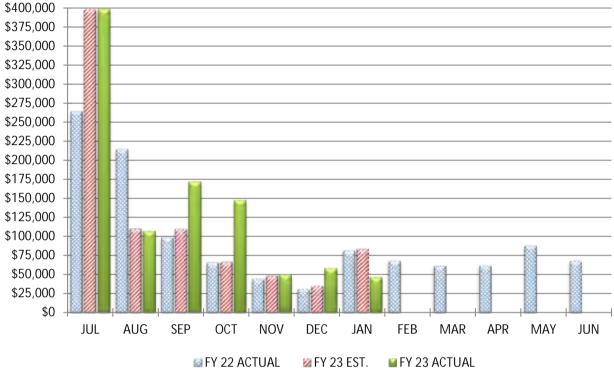

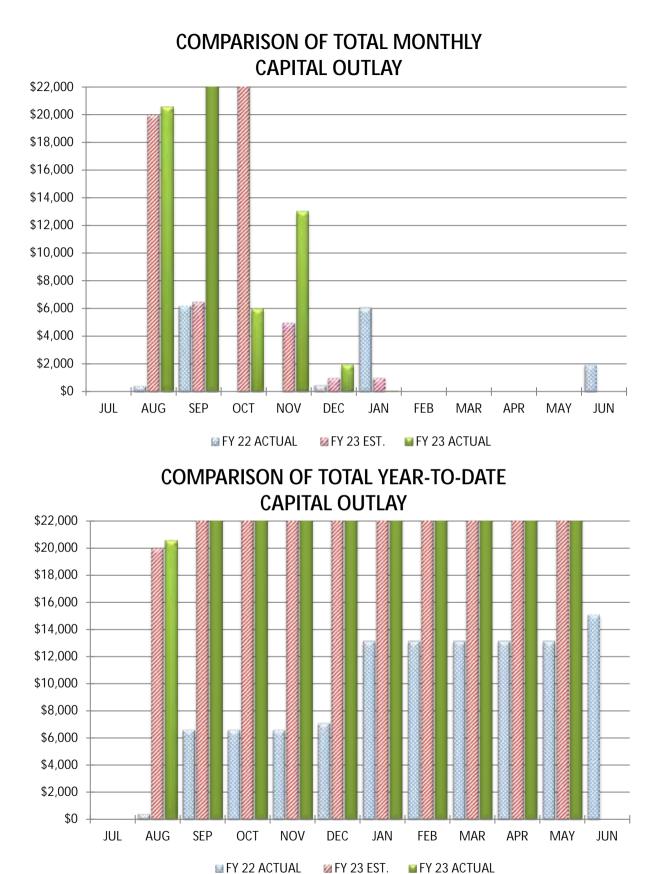
