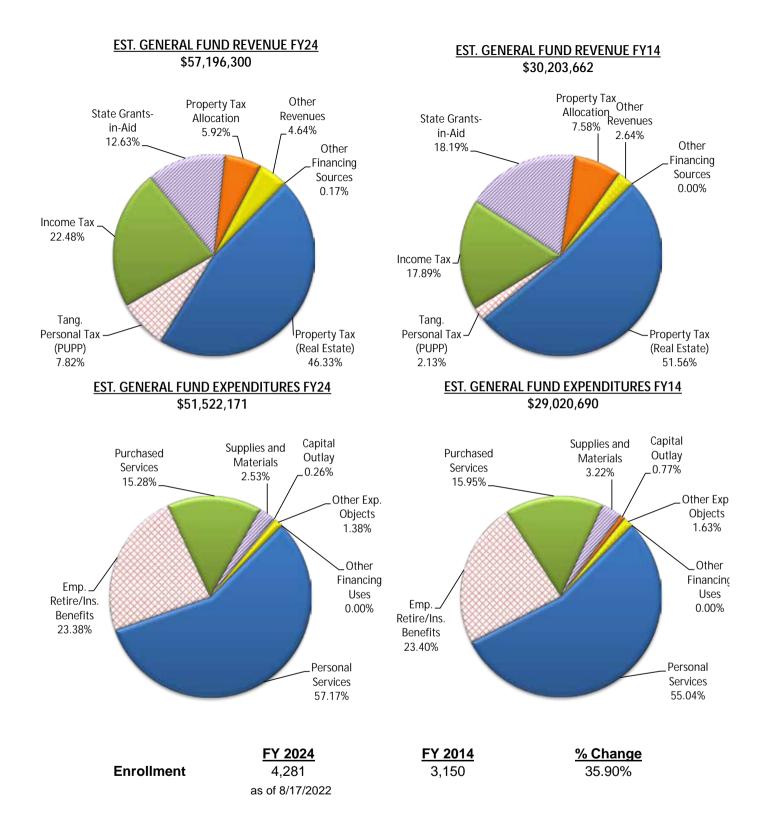

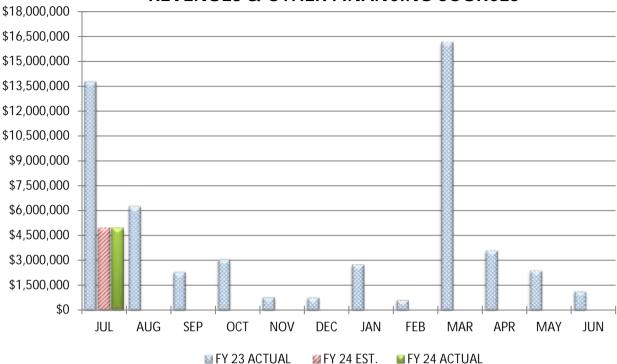

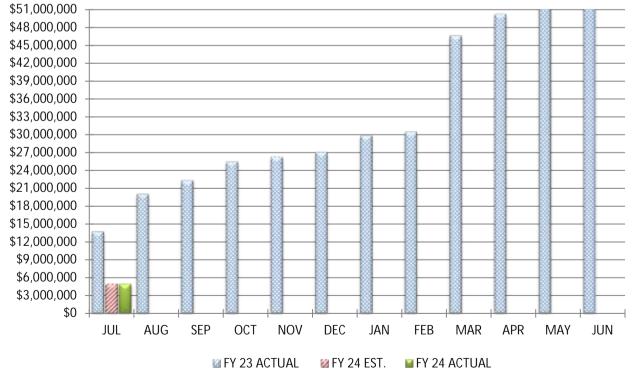

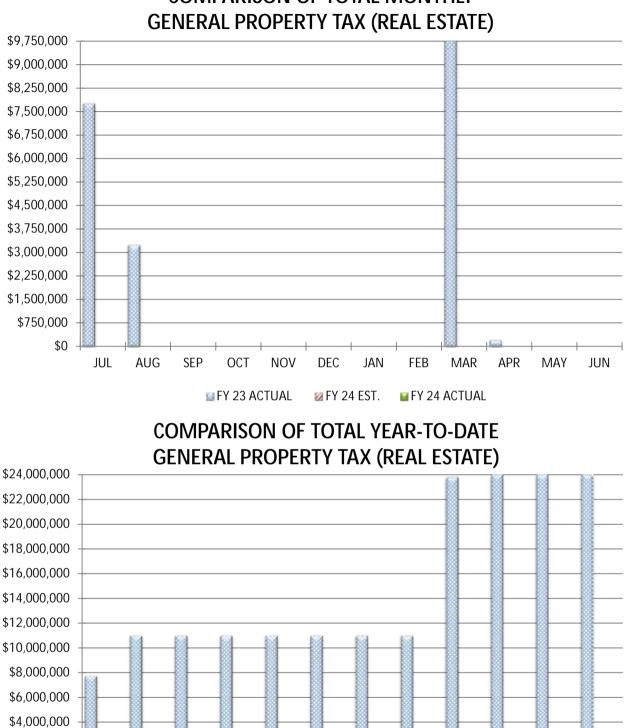

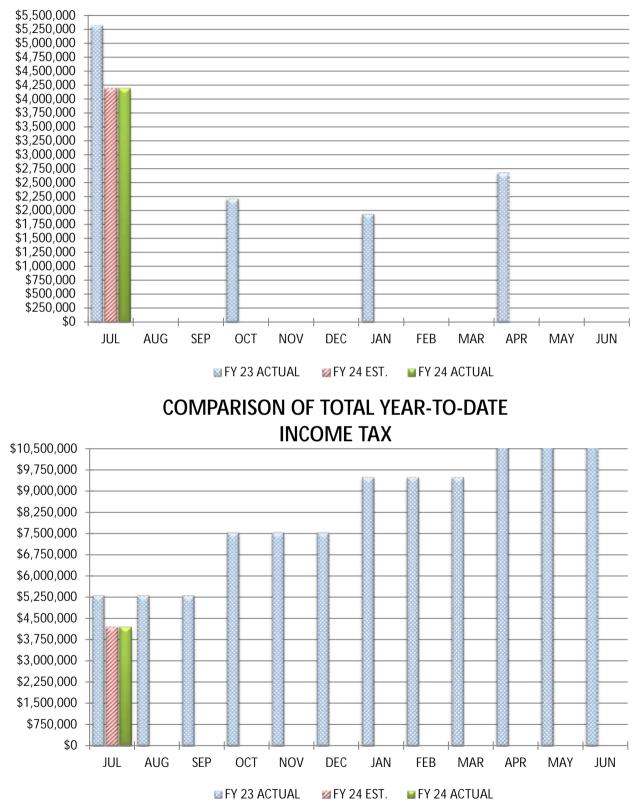

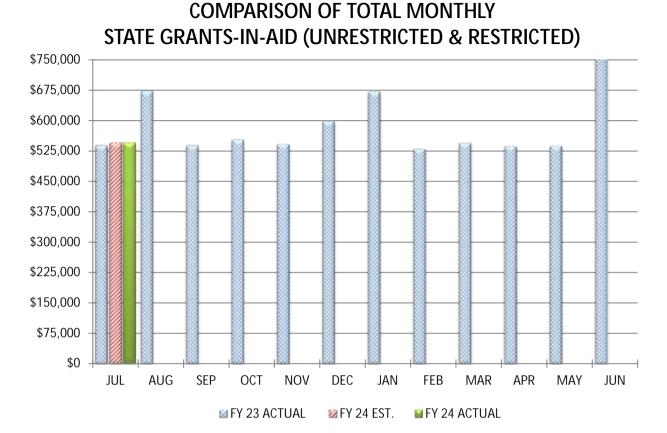
COMPARISON OF TOTAL MONTHLY INCOME TAX



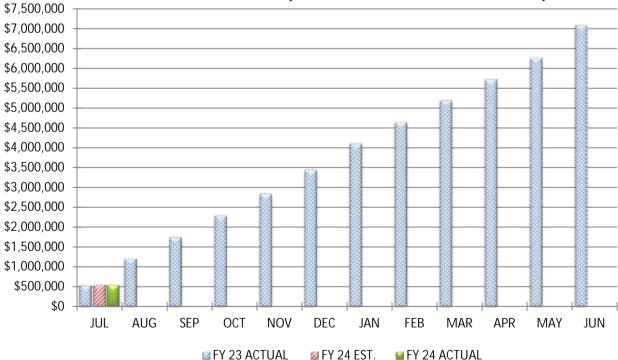

COMPARISON OF TOTAL YEAR-TO-DATE STATE GRANTS-IN-AID (URESTRICTED & RESTRICTED)

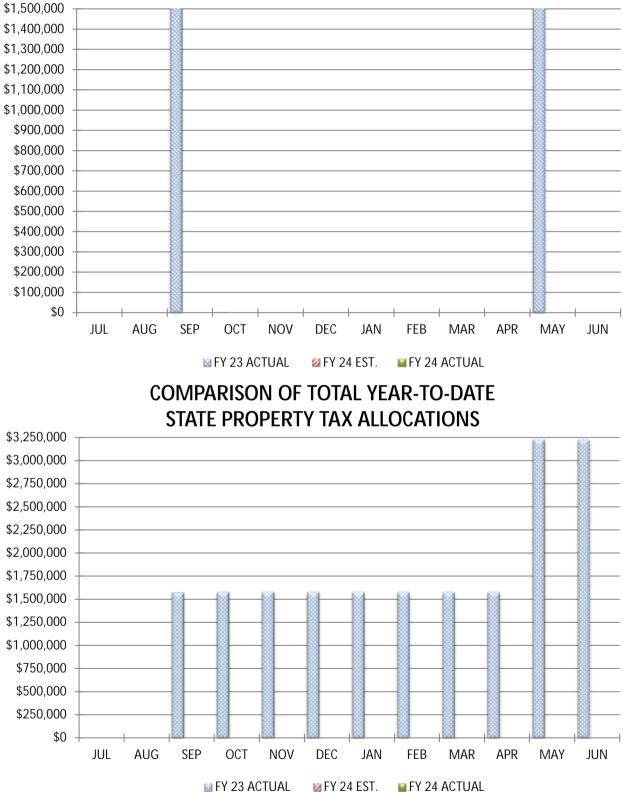

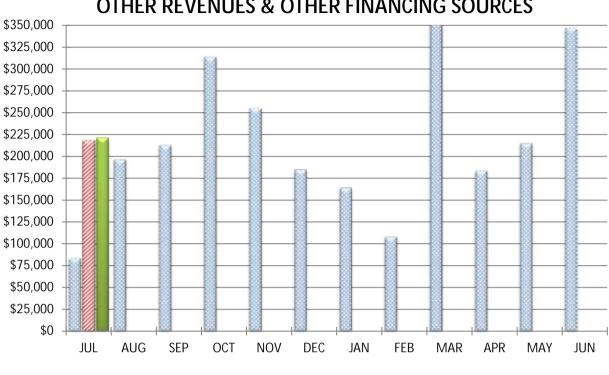
COMPARISON OF TOTAL MONTHLY STATE PROPERTY TAX ALLOCATIONS

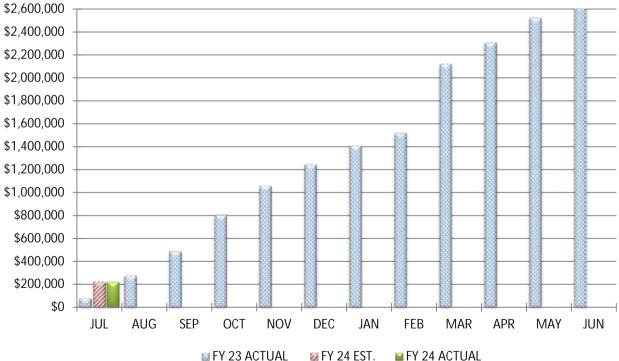

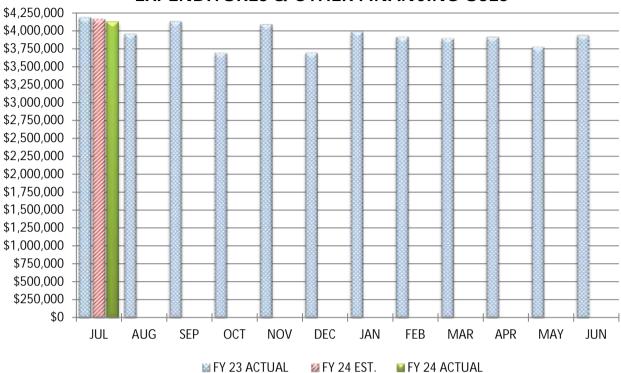

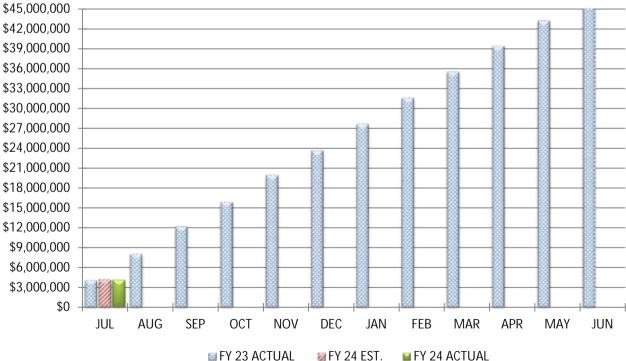

COMPARISON OF TOTAL MONTHLY EXPENDITURES & OTHER FINANCING USES

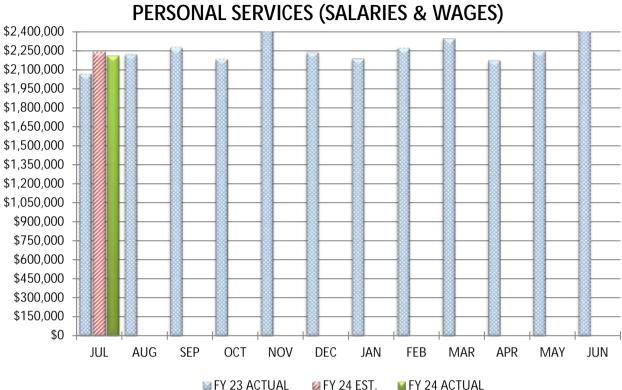

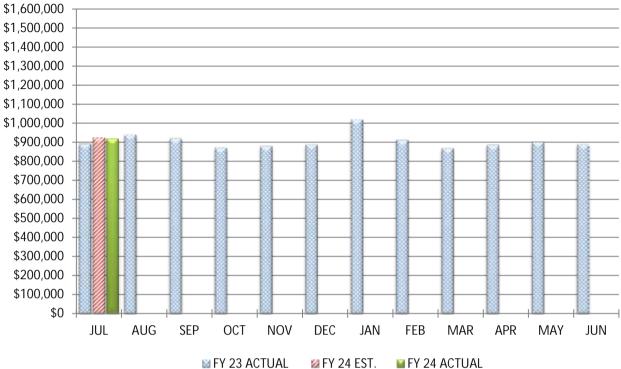

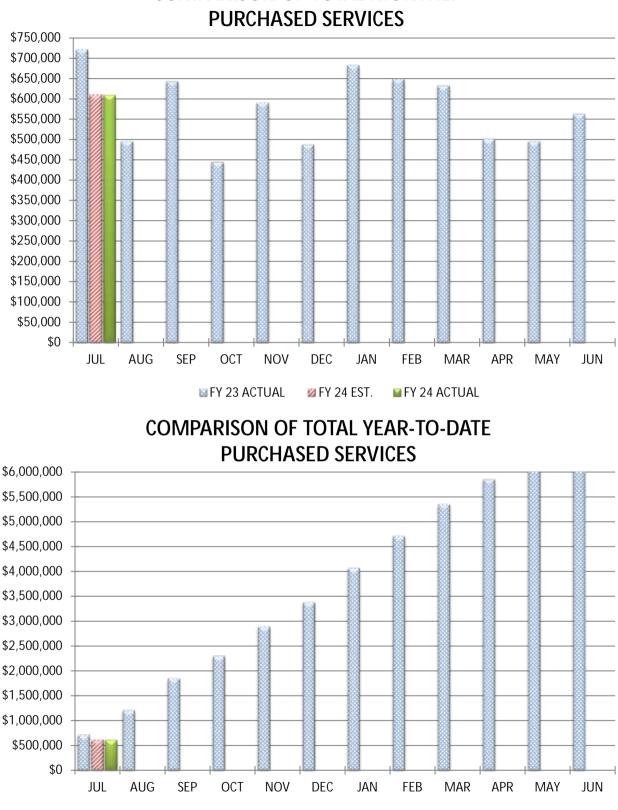

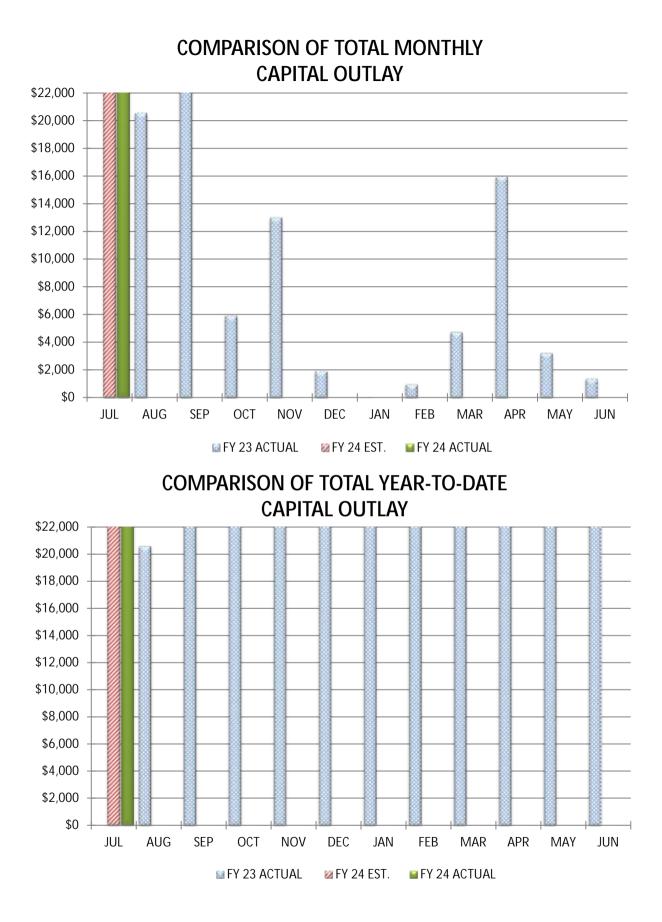

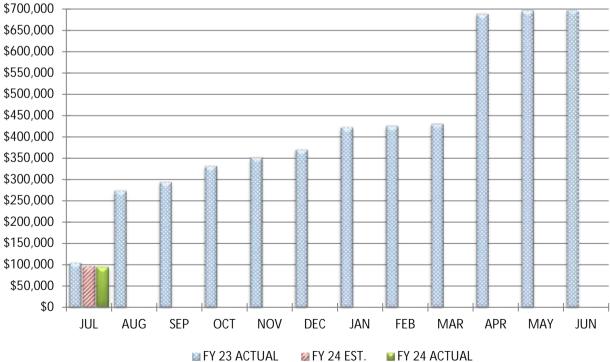
