COMPARISON OF TOTAL YEAR-TO-DATE REVENUES & OTHER FINANCING SOURCES

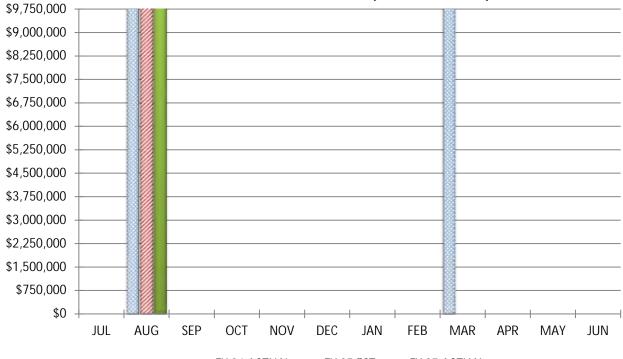

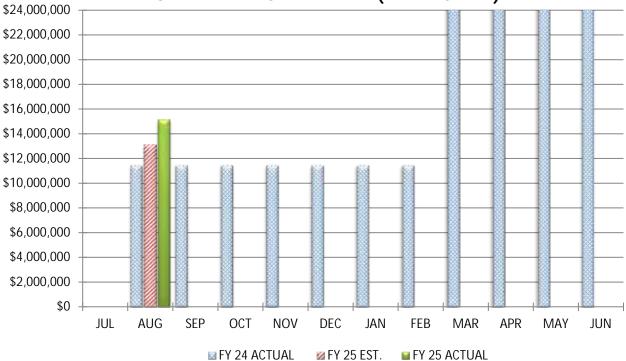

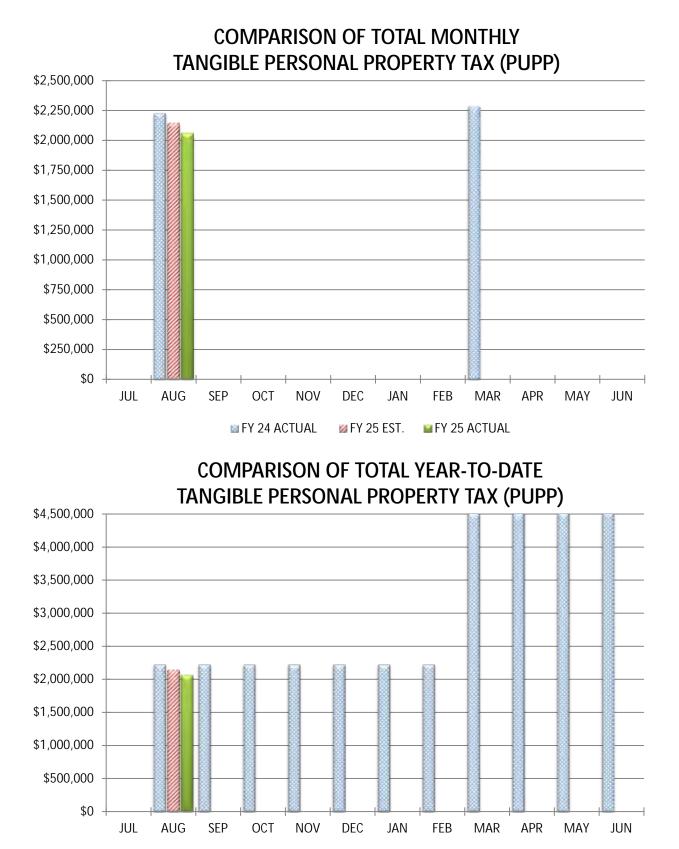

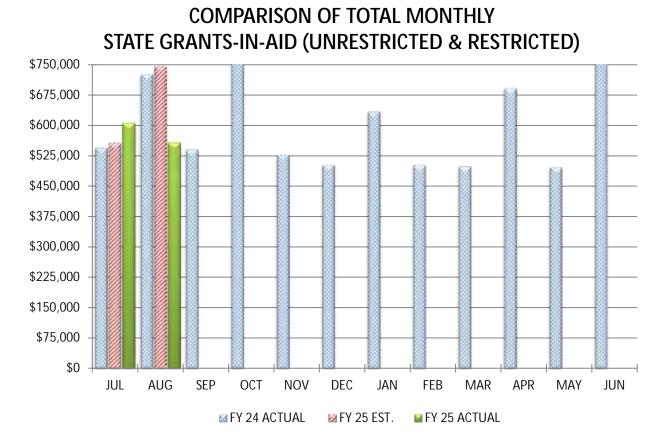
Comparison of Total Monthly Income Tax



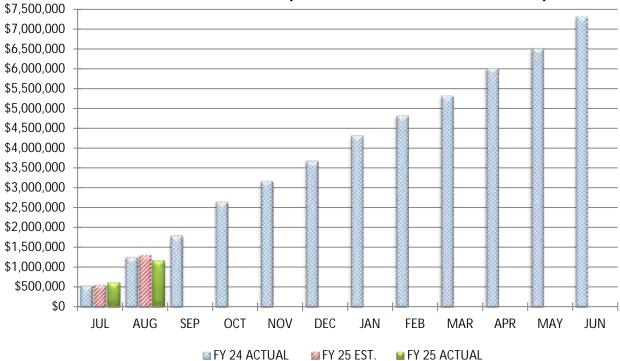

COMPARISON OF TOTAL YEAR-TO-DATE STATE GRANTS-IN-AID (URESTRICTED & RESTRICTED)

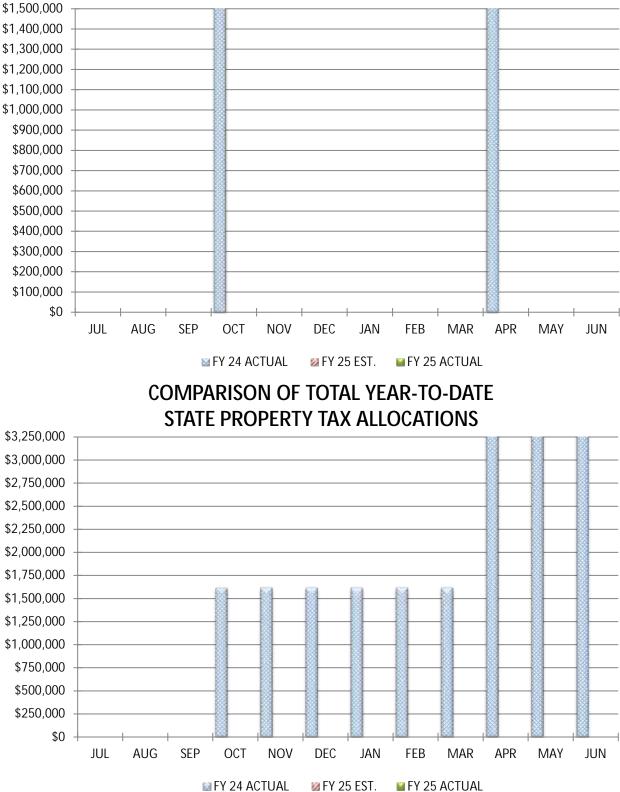

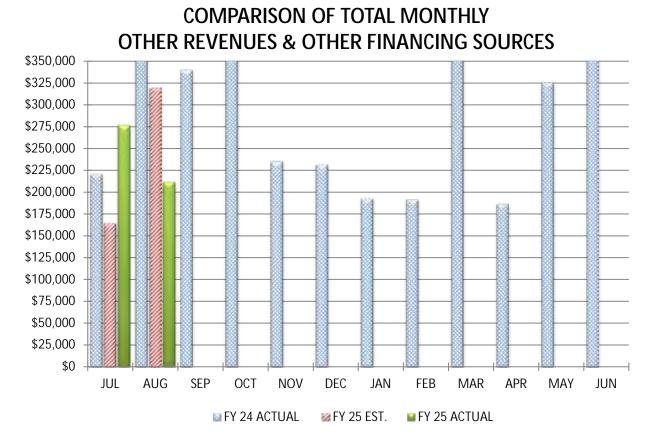
COMPARISON OF TOTAL MONTHLY STATE PROPERTY TAX ALLOCATIONS



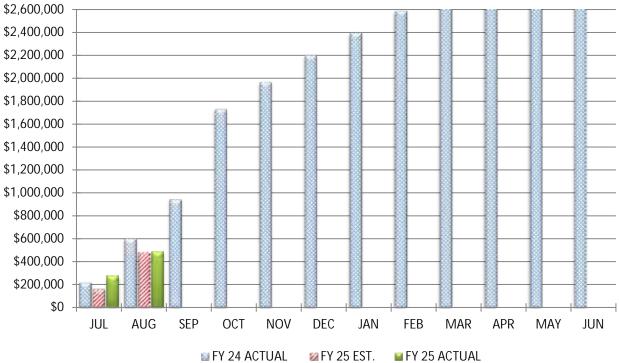

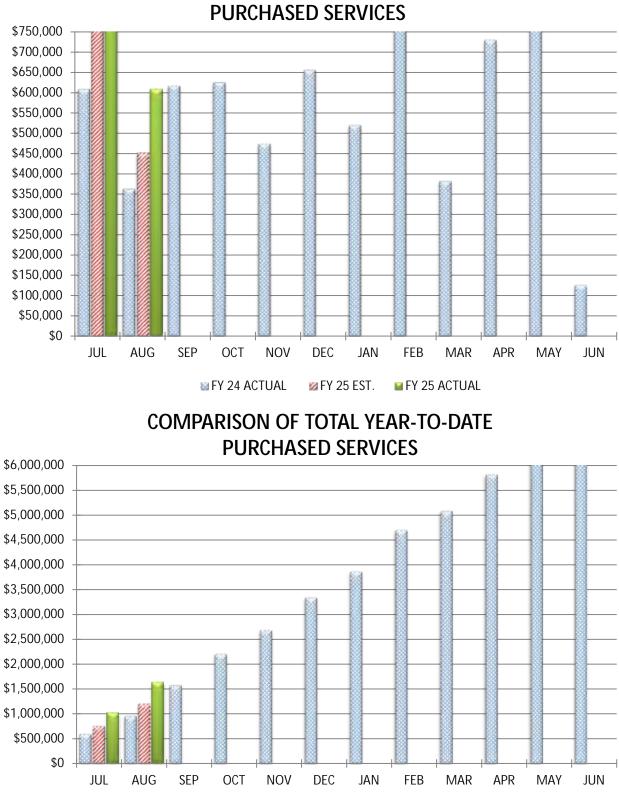

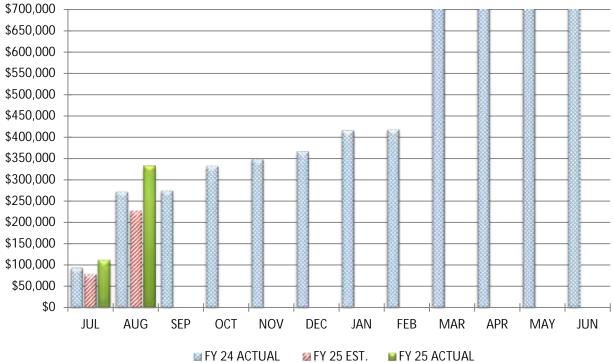
